Newberg's Anti-Saloon League.

The meeting held in the Baptist church Tuesday evening for furthering the organization of the anti-saloon league, of Newberg, was quite generally attended, more representative citizens being present than at the meeting of last week. It is still evident, however, that some of our leading citizens need waking up on this question, and the league intends to prosecute its work in such a way that they will be forced to take a stand for or against the organization. We have heard that some insinuate that the movement is a party concern. Their ignorance is thus displayed. The first principle of the anti-saloon league is its non-partisanship, and no citizen can honestly shirk responsibility from this standpoint. If a man is in favor of a saloon let him say so and we honor him more than the man who pretends to be for temperance, but is not at hand when an opportunity comes for practical temperance work at home.

At the opening of the meeting, Prof. R. W. Kelsey, president-elect of the league, made a short and forcible address, setting forth the object of the organization. He said, "We are here to keep out the saloon, which breaks up homes, blasts fond hopes and crucifies anew the Son of God. The saloon is waiting just outside, ready and anxious to come in. Will we allow it? We are here to enforce existing laws and to enact new ones in the interest of the boys and girls of Newberg. Every father and mother in Newberg, who would keep the footsteps of their boy steady, who would keep his heart pure, his voice free from the huskiness of the beer blot, and his being free from the paralysis of poison, who would keep the blush of shame from their daughter's cheek, is invited to cooperate with us in this work."

Mrs. G. W. Cutts was elected secretary of the organization, in the absence of that officer elected the week before. The committee on constitution reported, bringing forward the regular constitution of the national league, which was adopted with slight modification. Some of the principal points are as follows: The organization in Newberg is purely local, having no connection with national or state organization. The league is non-partisan, and has only for its object the suppression of the saloon. Any adult person in sympathy with the movement may become a member by the payment of an initiation fee of ten cents. The executive committee will be made up of the officers of the league, the pastors of the affiliating churches, two lay members from each church, the president of the college, the principal of the public school and five members elected at large by the executive committee. This committee appoints from its membership sub-committees on agitation, legislation and other departments of work. The regular meetings will be held on Tuesday after the second Sunday of each month.

Rev. Barr said he did not want the impression to get out that this was a preacher's organization, and as the president of the college, a member of the state legislature, and the city mayor were present, he would like to hear from them.

Pres. H. E. McGrew responded that he was in entire sympathy with the movement, and desired to co-operate in every way possible. He said he would be unworthy of his relation with the young people of the college and community, if he took any other stand. It is just the right kind of an organization.

Hon. Clarence Butt said, "This is the day and time to go to work. I am glad I'm here and am in entire sympathy with the work or I wouldn't be here. This is a grand undertaking, and every member should have a part in active service. Newberg has a good reputation now, but we may wake up too late to find that other elements have become

too strong for us. I pledge my support in any way to show where we stand on this great question."

Mayor J. G. Halley declared that he had never been otherwise than in sympathy with such a movement, and that he had no other desire than to do all in his power to further the good of the organization. Before the meeting was adjourned, many new names were added to the membership list. The executive committee is being organized and by the time of the next meeting, definite steps for active work will have been taken.
