Secretary of State Dunbar has made out a list of the clerks which served their state patriotically at the last session of the legislature, which shows that an army of one hundred and thirty-three clerks received an aggregate salary of \$22,000. We suppose the state may now congratulate itself on being better served than it knew.

Upon the close of a hard fought municipal election in Woodburn the editor of the Independent gives some sensible remarks on taking defeat gracefully, adding that apparently the happiest man right after the recent senatorial fight at Salem was the defeated Mr. Corbett. If our memory serves us well, that open letter to the "stalwart 28" would not indicate to the casual reader that the old man was wildly bubbling over even with apparent joy and enthusiasm.

An article from the pen of Moses Votaw on the army canteen question will be found in this issue. The Graphic grants the right of every man to hold and express an honest opinion and it only asks the same privilege at the hands of others. If it be proven by experience that conditions are bettered by the banishing of the canteen the Graphic will be glad to note the change. The influences that surround our soldiers are little else but evil and anything that will lessen the evil in any way should be welcomed by all good citizens.

It is observed by a contemporary that there are numerous ways of getting the bible into the hands of the people, and the various Christian missionary societies have spent vast sums to this end. But a firm in Toronto, Canada, is engaged in circulating the good book and making a pile of money by a clever advertising dodge. They advertised, "On receipt of \$1 we will send, securely sealed, a beautiful bound book of 400 pages, full of good things. Every sport should have one. The most wonderful book ever written. French and English translation. Prohibited in some countries. Write at once." The detective department of Canada, sending the circulation of improper literature, sent a dollar and received a 15-cent bible. They have not interfered with the sales, not caring to curtail the propagation of the gospel.

In the unveiling of the granite shaft at Champoug, on May 2, in commemoration of the historic day when Colonel Joe Meek dramatically called for a "divide" on the question of provisional government our people will have the opportunity of attending at their own doors an event of state if not national significance. The ceremony and attending addresses will be of special interest to old pioneers, and should be to those of a newer generation, whose pride and study should be the history of our grand state, not richer in natural resources than in the heritage of that hardy, sturdy pioneer character which makes a commonwealth called great. Governor Geer is taking personal management of the unveiling ceremonies, and preparations are on foot to make the day one of great historical interest. Among the great throng of visitors which will be present on this occasion, Newberg should have a large representation.

Under the editorial caption of "Short-sightedness" the Eugene Register takes the Salem Journal to task for intimating that our sister state of Washington is securing the great majority of eastern immigrants because the railroads discriminate against Oregon in giving their passenger rates. The Register maintains, and we believe rightly, that the wide awake people of Washington have more to do with this state affairs than have the railroad people, and further suggests that a tour of observation through one of these immigrant trains would disclose a lot of Washington advertising literature in the hands of the new comers, while Oregon would not be represented for the simple but effective reason that we haven't the literature. The fact that Oregon's resources are ahead of Washington's, does not help matters with us any as long as people in the East are ignorant in this respect or are made to believe by enterprising Washingtonians that there is nothing worth considering out in this direction south of the Columbia anyway. Instead of growling at the railroads for carrying people where they want to go, it would be the better part of wisdom to display a little enterprise in telling people about Oregon.

**Pullman Ordinary Sleepers.**  
The tourist travel between the East and the Pacific Coast has reached enormous proportions in the last few years, and calls for a special class of equipment. To meet this demand the Pullman Co. has issued from its shops what is technically the "Pullman Ordinary Sleeper." These cars appear similar to the regular sleepers being built on the same plan, but not furnished with the same elegance. They are equipped with mattresses, blankets, sheets, pillow cases, towels, combs, brushes, etc., requiring nothing of the kind to be furnished by the passenger. Each car has a stove for making tea or coffee, and doing light housekeeping, and each section can be fitted with an adjustable table. A uniformed porter accompanies each car, his business being to make

upberths, keep the car clean, and look after the wants and comforts of the passengers. In each of the trains which are dispatched daily from Portland by the O. R. & N. Co., is to be found one of these Pullman Ordinary Sleepers. The car attached to the "Chicago-Portland Special" goes through to Chicago without change, and the one in the "Atlantic Express" runs to Kansas City without change. Passengers in this car for Chicago change to a similar car at Granger.

Much of the first class travel is being carried in these cars, the rates being lower, and the service nearly equal to that in the palace sleepers.
