He says there is no doubt as to this district being an oil region and that he found the general conditions similar to those in Pennsylvania and other noted oil fields. He will later make a written report of his investigations here. Prof. Fisk has had many years of experience in this line of work in all parts of the United States, and a conversation with him is highly entertaining and instructive.

If the little gavel which Dr. Cardwell, president of the Oregon State Horticultural Society, used at the meeting here last week could only talk, it would no doubt have made the most interesting address of the session, from a historical standpoint. It is made of wood taken from the first cultivated cherry tree grown west of the Rocky mountains. The tree, rooted in Iowa dirt, was brought across the plains in 1847 by Henderson Lewelling, Oregon's pioneer nurseryman, and planted near Milwauke, where it still stands. The first cherries taken from it brought one dollar per pound, so says Dr. Cardwell. The gavel was presented to the State Horticultural Society by J. H. Lambert of Portland, propagator of the Lambert cherry, who has owned the historic tree for forty-eight years. The tree is of the Royal Anne variety.

It has been discovered that lands in close proximity to Newberg contain the true indications of coal and oil deposits, samples of croppings and specimens of underlying strata taken from the head of Chehalium Valley having been submitted for inspection to experts and geologists familiar with conditions in Pennsylvania, Texas and California and pronounced as true indications of oil. There seems to be little question as to oil deposits, the real question being one of quantity, which has at one time had to be met by all the great oil fields. This phase of the matter now being up to Newberg and Yamhill county, a company known as the Yamhill Coal & Oil Company has been incorporated, with organization almost complete, which will soon issue a prospectus setting forth its plans of operation and soliciting the co-operation of the people. It is not easy to estimate what the relation and value of the discovering of oil here would be to Newberg and the county, it only being needed to look at the rapid development of certain California towns which have struck oil, to appreciate something of the far reaching results of such an enterprise—when the oil flows freely. At any rate, with the encouraging prospects here, it would seem that the possibilities of success are worthy the efforts of the people in this direction.
