After a trial which consumed only about eight hours time the assassin who murdered McKinley, was found guilty of murder in the first degree. Thursday was set by the judge as the time for passing sentence on the criminal.

Reports come from Salem that the exhibits at the state fair are the best that have ever been on the grounds. Nearly three hundred head of cattle are on exhibition and Dr. Withcombe says the stock exhibit is the best, with the exception of that of the Illinois state fair, given in the United States. Yamhill county has a very fine exhibit which was gotten up by a young man named Lafolette.

The award of the Wilder medal to the state of Oregon for the horticultural exhibit at the Buffalo exposition, made a few days ago by the American Pomological Society, is the climax of a long line of similar victories for our state. This latest award is a sweep-stake award, from the highest existing authority. Oregon does not too her horn as blantly as some of her less worthy sisters, but allows her products to tell the thrilling story of an incomparable commonwealth in their own silent but effective way.

President Roosevelt, with a view to inspire general confidence in himself as a safe and capable executive, could not have acted with greater discretion than has characterized his first actions in office. When inaugurated, he declared it would be his course to follow out the policies of the late President, and has strengthened and backed up the declaration by retaining the old cabinet. President McKinley had a genius for surrounding himself with the ablest of men as counselors, and the fact that these same men are to advise and support the new president, conduces much to a feeling of trust and confidence among the people. Farther than this, President Roosevelt's course indicates that he has no immediate political debts to pay, but is free to select the very best men for positions of trust.

A county exchange quotes the following from the Graphic, with the comment that it does not mean what it says: "The despicable lunatic, who with one hand grasped the hand offered in the spirit of fellowship, while with the other he treacherously laid low the one who extended it, is not of himself worthy of thought or attention, but the spirit above of which this dastardly act is the exponent, is worthy the most careful attention." The Graphic's presumptions enough to hold that it does mean just what it said—that very thing. It has no sympathy with the wild-eyed and loud behaving of some big preachers and politicians, who cry out hysterically, "Lynch him." "Dash his brains out on the spot." Burn him alive." Such a hectic and hysterical explosion is wholly unworthy of American citizenship. The exchange in question, it seems, would have a great public show and example made of the assassin. A wish for that very thing is doubtless what prompted the fiend. A dyed-in-the-wool anarchist craves such treatment, and when you make a big public spectacle of one, you have ten more to deal with. The assassin should be summarily but quietly executed, and the attention of the country turned from the actor to the spirit of anarchy abroad which makes such an awful tragedy possible.

IN MEMORIAM.

Fitting Services in Honor of the Nation's Dead, at Which Many Inspiring Addresses were Made.

The attendance at the memorial services held in the Friends church Thursday of last week was a fitting tribute to the honored name of the nation's fallen chieftain. All business in Newberg was suspended, and the people gathered to mourn for the loss of a personal friend.

The civil war veterans, accompanied by the W. K. C., attended in a body, and the deep feeling they manifested during the services spoke eloquently, and was besting the defenders of the Nation.

The exercises of the morning began at 10 o'clock with the singing of the appropriate hymn, "My Father Knows." The 39th Psalm was read by Rev. H. Gould, after which Elder Geo. C. Carl offered a fervent and impressive prayer. In the course of the services, such fitting hymns as "Lead Kindly Light," "Nearer My God to Thee" and "Sometime We'll Understand," were rendered.

The short addresses of the morning, five in number, were particularly good and all worthy of special mention. Though eulogistic in character, they were also deeply thoughtful, many strong thoughts being presented. A few of the leading thoughts of the addresses are given below.

Prof. R. W. Kelsey.—The spirit of sympathy with the actor in the Buffalo tragedy is a dangerous enemy to our country. One who sympathizes in any way with the assassin of President McKinley is a traitor unfit to live longer beneath the flag. Criticism of the political policies of men has its place, but all should mourn the beloved dead of

the nation. We cannot understand why there is so much suffering in the land, but we do know that if all hearts and homes were as pure as was his whom we mourn, countless sorrowing hearts would be turned from grief to gladness. To such a man should be entrusted the welfare of our country. High as his name will be written on the scroll of fame, higher still will be read the words, "He was true to his home."

Rev. F. C. Stanard.—We cannot understand why our prayers for our President's recovery were not answered. The tragedy was not God's purpose, but the work of the arch fiend, through the hands of a man after his own heart. God allowed his own son to be destroyed by Judas and thus was wrought the salvation of the world. Sacrifice, is the lesson of history, and we may still look up with faith through our mist of tears to Him who doeth all things well. The assassin's bullet does not mark the ending, but the widening of a noble career—a further promotion. The martyr's noble character now speaks with greater force than it otherwise could. The nation is tendered and united. The brave, inspiring death of the President stands out as a precious boon to Christianity.

Jesse Edwards.—There is a universal conflict between good and evil. President McKinley with his high character is a fallen champion of the good. He was not perfection—he made mistakes—but his motives are unquestioned. The assassin, together with all his supporters of whatever degree, is possessed of the evil. The tragedy should bring a deep lesson to all of us to be careful of our influence, lest in any way we encourage such a catastrophe. If conditions don't change, if there is not a different attitude manifested toward our chief executive, this page of our history will again be repeated. It is hopeful, that the tears of the nation have been flowing freely over its great affliction. The fallen chief will still live in the lives of other men made better by his noble life.

Hon. Clarence Butt.—There are few men who have accomplished in 58 years as much as he whom we mourn today. Nothing was won by him but by energy and perseverance. He won the respect of those who opposed him, and also the respect of the whole civilized world. Today the representatives of foreign countries who knew him mingle their tears with our own. As a statesman, he was broadminded and capable; as a politician, clean and open; as a public servant, faithful; as a man, model and ideal; as a Christian, devout and faithful.

J. C. Hodson.—The pistol ball of the assassin pierced the manhood of the nation. Lincoln's death showed conclusively that our nation was capable of undergoing and surviving great shocks. Garfield's death, the result of bitter factional strife, brought a cleaner era in politics. Shall we not learn a lesson in this tragedy? We now realize that there are dangers to the country in free speech; that severe and unbridled denunciation from press and pulpit bears bitter fruit. May we learn the lesson well. Our president is gone, but another, capable and brave, is at the helm and the star of hope still shines for a sorrowing people.

The Cow and the Hen.—When the economical housewife goes to the store and fifty-five cents per roll is demanded for creamy butter and fifteen to twenty cents per dozen for eggs, she looks askant and wonders when the cow and the hen will get down to business and enter into the spirit of expansion which she reads so much about of late. The following note along this line from the Oregonian will be of interest. "Notwithstanding the great expansion of the dairy business in this region of late, the supply of butter is not equal to the demand, and Eastern butter is finding its way to this market again. Last year there was no eastern butter brought here, but the long spell of dry weather the last summer had the effect of lessening the output, and the population of the city has been increasing rapidly, consequently Eastern butter will have to be imported. Last Spring, when the supply of butter began to exceed the demand, a large quantity, some 150,000 pounds, was bought up and put in cold storage. This has been nearly all disposed of already, and as the present output of the dairies is not enough to supply the demand the shortage will have to be made good by Eastern butter. Eggs of late have been scarce, and several carloads have been sent from the East, but none of them have come here, so far as known. With eggs at 25 cents a dozen in Portland and 18 cents per dozen in Chicago, there is a good margin for importers. After harvest, the output of eggs always increases, and it is said that there will be more chickens engaged in laying eggs in this section this fall than ever before. It is highly desirable that Oregon should produce enough eggs and butter for home consumption, at least.

The great carnival which opens at Portland on September 19, and continues until October 19, 1901, will be well worth a visit to the metropolis. Exhibits of agricultural and horticultural products, mining and manufacturing industries, athletic exercises, a horse show at which feats of horsemanship and the various forms of fancy riding will be seen, and a magnificent military tournament, participated in by picked companies from the Oregon National Guard, are a few of the attractions at the carnival this year. The Southern Pacific Co. will sell tickets at low rates for this occasion, and will also run a special excursion from Ashland to Portland and return, stopping at all intermediate stations, the date and rates for which will be announced hereafter.
