Twenty years ago kerosene oil was practically unknown in China. In 1900 more than 100,000,000 gallons were imported. But it must be remembered that but little was known of John D. twenty years ago.

Governor McLean, of Connecticut, when asked to contribute a biographical sketch of himself to "Who's Who in America," wrote: "McLean, George F., Governor of Connecticut, 1901-03. Republican. Address, Hartford, Conn."

The Indianapolis Journal suggests that the genius who evolved the theory that because President Cleveland's two terms of office were not continuous he should therefore be counted as two Presidents, whereas each of the others who served two continuous terms should be counted but once, should retire to the obscurity from which he emerged. Mr. Cleveland may be a big man, but he is not big enough for two.

In a public address, delivered in 1891, Ex-President Hayes said of McKinley, who enlisted as a private in an Ohio regiment at the age of 17: "Young as he was, we soon found that in business, in executive ability, young McKinley was a man of rare capacity, of unusual and unsurpassed capacity, especially for a boy of his age. When battles were fought or service was to be performed in warlike things he always took his place. The thought was never too dark; the weather was never too cold; there was no sleet, or storm, or hail, or snow, or rain that was in the way of his prompt and efficient performance of every duty." The boy was father to the man. "Prompt and efficient performance of every duty" should be the watchword of every young man who cares anything for his future.

Henry Watterson in the Louisville Courier-Journal says of McKinley: "The notion that he was not his own master, and the master of all about him, was singularly at fault. Nothing could be better proof than his fidelity to his friends. It is the weak man who kicks away the ladder when he has climbed to the top. McKinley showed himself grateful to every friend of the ladder. In his heart he feared no man's rivalry, not even the accusation and appearance of a diversion of power. He knew as few men have known how to say 'No,' as if conferring a favor and to send the suitor away at least half satisfied. Critics seeking to deny him the higher virtues of statesmanship called him a clever politician. And so he was. But was it only clever politics that was able to hold the government well in hand and keep it out of a premature declaration of war until the moral basis of that war should be clearly laid and the people be thoroughly united? Was it only clever politics that pilot the ship of state through the breakers which succeed all wars and to bring her back into port intact and with so little strain that thus far we can scarce see any sign of danger, or even of stress of weather? What may betide, what may be hid in the womb of the future, we know not. We can only judge the sailing as far as we have gone. The elements may thicken and grow dark. The skies may be overcast. But the sailing has been too smooth over seas that have been so strange for anybody to deny the natural statesmanship, however he may dispute the doctrinal statesmanship of William McKinley."

THE DEATH OF A CHRISTIAN.

The Graphic thinks it will not be out of place for some people away out here in Oregon to read the following editorial taken from a recent issue of the Indianapolis Journal: "The sublime courage and Christian resignation with which the dead President faced the certainty of death has touched the heart of the world. 'Good-bye, all; good-bye. It is God's way. His will be done.' These are the words that have flooded eyes of thousands upon thousands unused to tears. In the grasp of death the late President's poise and courage and even his cheerfulness did not forsake him. To him there was no 'king of terrors' to him death was no 'grim foe.' Life was as sweet to him as it could be to any man; yet when he was sure he must leave it, he did not repine. His life had been every way so clean and sincere, and his faith in God's wisdom and justice so complete that he could say: 'His will be done.' While in the borderland separating the world of sense from the unseen, it was natural that he should say, 'Nearer, my God, nearer to Thee.' The world knows now that Mr. McKinley was a Christian man and led a Christian life. Not to reproach those professedly good who have assailed the late President on moral grounds, but to enforce the importance of Christian charity, attention is called to the fact that his life and conduct were impugned for more than a year previous to the last election. Spies followed him to banquets to see if he drank wine, and hung about the entrance to his rooms in a Chicago hotel to see if wine was not taken thither. Because champagne was taken to his apartments for Mrs. McKinley, vindictive zealots proclaimed the fact in an alleged temperance paper as evidence that he was a winebibber. Organizations bearing a Christian name were assailing him on the ground that he was the ally of the 'rum power,' and

prayer chains were put in operation imploring God to compass his defeat because he was not a Christian man. It was the zeal of conscienceless hate that led persons to do these evil things. Now all see that this assailed man approached death with the tranquil faith of a Christian. Should not the acts in connection with the last days and the death of the late President lead us to practice Christian charity which shall, at least, make us truthful when character is involved?

PACIFIC COLLEGE OPENS.

Many New Students in Attendance and a Good Year Promised.

The new school year of Pacific College was ushered in very auspiciously Tuesday morning, more new students being in attendance than has been known for several years, the majority of the old ones also being back. As usual, the exercises of the morning were of a public nature, and many friends and patrons of the college were present, both to profit by the program and to encourage the students and management. Many words of interest and inspiration were spoken, which all the students, both new and old, will do well to treasure in the days of work to come.

The devotional exercises were conducted by Rev. L. T. Barr, who took occasion to deliver a welcome from the standpoint of a Christian minister, and who expressed the thought that the precious relationship of other days was but an earnest of future associations between him and the students.

After the rendition of an instrumental solo by the new music instructor, Mrs. Chrisman, Jesse Edwards was called upon by Pres. McGrew as an old "stand-by" of the college who always had something of profit to say to young people. After giving a humorous retrospective view of Pacific College, Mr. Edwards expressed the belief that the institution is now in a better condition for good work than ever before, is better advertised, and is better off financially. He said that always having felt a personal interest in the students of the college, he had followed their course in after life, and was pleased to know that as a rule they had met with good success. He gave as an appropriate motto the words "grit will win; grit always wins," and encouraged the young people to form strong resolutions for success. He further recommended them to the faculty and people of Newberg as always willing to extend them a helping hand.

Rev. T. Brionette, pastor of the Presbyterian church, said he was proud of being a resident of a town which has so loved the young people and their education that such sacrifice has been made in this direction. This very sacrifice is a guarantee that the good people have at heart the best interests of the students and are ready to help them in time of need. Prepare well for the duties of life. The struggle on is between mind and mind, and intellectual equipment is as necessary as material. Intellectual training cultivates the habit of independence and self-reliance as a vital factor toward success.

The noblest ambition is to gain wisdom, said Rev. F. C. Standard, pastor of the Baptist church. Aim to be the very best possible in life, to be someone of usefulness than a long life of inactivity. The speaker emphasized the necessity of physical as well as intellectual culture.

Rev. Jos. Hall emphasized the need of determination, which makes real men and women. The world is demanding positive characters, which stand for something. The making of character is the objective point.

B. C. Miles, president of the board, wished to leave one thought with the students; that both the good and evil classes of the world are looking for such capable young people, and that while the student's presence in college indicates that he wishes to become one of the first class, yet his daily life in school will decide the momentous result. Character is not made in a moment, but is made up of moments.

After a vocal solo by Miss Edna Hobson, the faculty was heard from briefly. Pres. McGrew introduced Prof. H. Rosenberger of Oskaloosa, Iowa, as the new member of the faculty, who spoke of the tri-fold development, mental, spiritual and physical for which collegiate institutions stand, explaining their inter-relationship, and emphasizing the need of maintaining an equilibrium in college training. Other members of the faculty were heard from in brief, the burden of their testimony being that they were there for the best interests of the students and stood ready to assist them in every way possible. The exercises closed with a vocal duet by the Misses Lucy Gause and Carrie Turner.

YAMHILL'S EXHIBIT AT THE STATE FAIR.

It is generally conceded by those in the habit of attending the state fair that the county exhibits made at Salem this year were the best they have ever been. All were excellent and any one was sufficient to open the eyes of a tenderfoot to the unexcelled productivity of this Oregon of ours. In the nature of things, however, there was a difference of opinion as to which county made the best showing, some declaring in favor of Yamhill, some for Marion, others for Washington, Polk etc. The judges, however, seemed to think differently from many others, and as a result Lin county secured first honors and Benton second.

Regardless of any arbitrary decision on the part of the judges, Yamhill had an exhibit of which any loyal Yamhiller who saw it was justly proud. To show that the exhibit of our county was worthy of special consideration, it is worthy of note that Yamhill had on exhibition two hundred more varieties of products than any other county; that

she exhibited the largest pumpkins, squashes (one of the latter weighing 110 lbs.), cabbages, turnips, melons, the largest headed wheat and the tallest corn, the latter standing 14 feet in height; that her exhibit excelled the majority in its arrangement.

To give an idea of what old Yamhill can do, and to show what other counties must have done to beat her, the following is a list of the varieties of products she had on exhibit:

In addition to the above there were on exhibit 300 jars of fruits, and a display of sweet potatoes, persimmons, kaffir corn, dried figs, ground-cherries, coal, and an orange tree in bearing.

All this diversified exhibit was gotten up by an enterprising young farmer of Wheatland, named Clyde La Follett, who has been a resident of this county but two seasons. Formerly he lived in Marion county, and for several years helped win the championship for that county, but on moving across the river transferred all his loyalty to the cause of old Yamhill. When talking to a representative of the Graphic he expressed a desire that the citizens of the county be thanked and commended for their cooperation, but when it is known that Mr. La Follett himself, on his own land, raised two thirds of all the products he had on exhibit, it seems more fitting that Yamhill should arise and give this young man a unanimous vote of thanks for the deserving efforts he has put forth in her behalf. With a few more such loyal and capable sons she could alone go up in competition against the whole state fair and win out. Next year let us see to it that Mr. La Follett has more help from some of our citizens who have lived in Yamhill nearly twice as long as young La Follett is years old.
