FOR ACTION AGAINST POLYGAMY.

Editor Graphic: I desire to call the attention of the public to a petition that is being circulated to ask Congress to so change the Constitution of the United States so as to make plurality of wives unconstitutional, which it cannot be legalized in any state.

The women of various Christian denominations of Utah appeal for earnest effort in this change of constitution by presenting the following facts: "In violation of the pledges of Mormon leaders, made before statehood, the president of said church is now living publicly, in his official residence in Salt Lake City with the last acquisition to his polygamous household. Former polygamists who, in obedience to law had practically ceased their unlawful cohabitation are now following his example, have resumed polygamous relations and have children by plural wives. This polygamous element is the dominant power in the church and in the politics of the state. Not only have many resumed polygamous relations, but the best of circumstantial evidence unmistakably points to the conclusion that Apostles John W. Taylor, George Teasdale, the late Apostle Abram H. Cannon and other prominent Mormon ecclesiastics have taken new plural wives. If such practices can be indulged in by those whom all Mormons semi-annually sustain as the literal "mouth pieces of God" and in spite of their most earnest protestations of good faith in promises made to secure statehood, then we must expect that this is the beginning of a general re-habilitation of this polygamous relic of barbarism."

These facts together with many similar ones all convince us that, since Utah statehood a powerful influence is working here for the re-establishment of, and increase in, the number and size of polygamous families. A strong organization has been formed in the East, called "The Interdenominational Council of Women for Christian and Patriotic Service," the officers of which are, president, Mrs. Darwin R. James; corresponding secretary, Miss Susan H. Ward; treasurer, Mrs. F. C. Morgan; vice presidents, Mrs. R. S. McArthur, Miss Helen M. Gould, Mrs. Chas. H. Parkhurst, Mrs. Wm. Kincaid, Mrs. Clinton B. Fisk, Miss Anna M. Hammer, Mrs. Frances J. Barnes, Mrs. George B. Watts, with an executive committee of prominent women from which come this appeal:

"To every Christian patriot in the United States we send an earnest plea for aid in fighting that monster evil of our Country, Polygamy. We desire to arouse the public conscience, that Congress shall accede to the demand of the people to make polygamy a crime in every state and territory in the Union. When Brigham Roberts was denied admittance to Congress it was because the voice of the people was raised against the holding by a polygamist one of the highest official honors in the Nation. The natural consequence of this act is a Constitutional Amendment which shall strike at the root of the matter and make polygamy forever impossible."

With these striking facts before us I appeal not only to the people of this community, but to the people of Oregon wherever this paper may go to seriously consider what our duty is in this matter and act accordingly. E. B. M.
