OREGON YEARLY MEETING.

In Their Annual Gathering the Friends of Oregon Consider the Interests of the Church and its Work. Other Points Well Represented.

When the first public session of Oregon Yearly Meeting was called to order Tuesday morning, a good attendance was noted from other meetings, much better in fact than from Newberg. As the meeting progresses however, the attendance increases. Among the visitors are Rev. Amos Kenworthy of San Jose, California, and Rev. Walter Vail of Philadelphia, though directly from San Jose.

The first hour of Tuesday morning's meeting was entirely devotional, many members joining in the service. The keynote of the meeting was struck by Pres. McGrew. He said, "We should not so much be concerned for individual blessing as for God's overflow, which shall reach out and give life to the passer-by." Another impressive truth stated by Rev. Jas. Price of Salem—"God is standing at the flood gates of our lives waiting to turn on the power to set in motion the machinery of the perfect life. And how many of us refuse to raise the gates!"

On taking up the business of the meeting, reports from Newberg and Salem quarters were read showing the spiritual state of the church. The epistle from California Yearly Meeting was read.

TUESDAY AFTERNOON.

Marion George of Portland conducted the opening devotional exercises in an inspiring manner. A hearty welcome was given to Amos Kenworthy of San Jose, California, who arrived just in time for this session. He is counted one of the pioneers among Friends in evangelistic work and it is felt that his presence will add greatly to the interest of the devotional meetings.

H. Edwin McGrew was appointed presiding clerk for the year, Marguerite Elliott, reading clerk, Mabel Douglas recording clerk, and J. S. Richie announcing clerk. The chief business of the afternoon consisted in the reading of the statistical reports. The general condition of the church was also under discussion. Another interesting feature of the afternoon was the reading of letters from London and Iowa Yearly Meetings.

The very fact that one meeting requested that its name be changed from Boise to New Hope, is perhaps a correct index of the general attitude of hopefulness which pervades the church and this feeling of encouragement seemed particularly manifest during the opening session.

WEDNESDAY MORNING.

The business session was opened by devotional services conducted by Rev. Elwood Knight, followed by extended remarks by Rev. John F. Hanson.

Epistles were read from Kansas and Iowa Yearly Meetings. The permanent board report that 1000 copies of the uniform discipline had been printed, 50 copies of which were bound in cloth, at a cost of \$136. The recommendation was made that the trustees be directed to purchase a case suitable for a depository for the documents belonging to the church, and that James Vestal be appointed as custodian of the same. The recommendations were adopted.

The conference committee reported that one very profitable conference was held during the winter at Marion.

A memorial to congress in opposition to polygamy which is being circulated by the National Federation of Women was directed signed and forwarded to Washington.

The clerk was directed to send a message of love to Mrs. Jane H. Blair who is unable to attend services on account of sickness.

WEDNESDAY AFTERNOON.

After the reading of the epistle from Western Yearly Meeting, Indiana, attention was given to the subject of temperance. In the superintendent's report of the work done, attention was called to the recent victory of Walter Miles in the national prohibition oratorical contest at Indianapolis. Memorials to our congressmen were adopted asking their support of the Hepburn-Dolliver bill. B. C. Miles and J. S. Richie, members of the Oregon legislature, were appointed as a committee to ask state legislators to enact a law making it a crime to take liquor into prohibition territory of the state.

Walter Vail of Philadelphia Yearly Meeting was introduced who spoke of the history of the Friends church in reform movements and dwelt upon the call to the church by the temperance cause.

The duty of the church in regard to the liquor traffic was handled briefly by Rev. J. F. Hanson of Boise, Idaho.

"The Bird With the Broken Pinion" was sung very effectively by Mrs. W. L. Robertson, which closed the program of the afternoon.

The Yearly Meeting continues throughout the week and over Sunday.

Newberg Postoffice Robbed Last Night.

Burglars entered the postoffice through the Graphic office last night, blew open the big safe and secured about three hundred dollars for their trouble, about seventy dollars of which belonged to Postmaster E. H. Woodward and W. C. Woodward. Powder was the explosive used, and the job was cleverly executed. No one heard the explosion, and the robbery was not known of until this morning. Though an expert safecracker, the burglar showed poor judgment in entering a postoffice this early in the month, when the postal funds on hand are very light. The best haul was made on the money order funds.

Together with the cash, nearly all the stamps were taken, also a book of blank money orders. The former were in a big red pasteboard box and the latter in a black tin box. As it is probable that the stamps and blanks were thrown aside when the boxes were opened, as some stamps were left rejected in the

office, any one finding them will confer a great favor by returning the same to the postoffice.

The burglars forced open Evans & Prather's blacksmith shop and secured the necessary tools for their work.

The program of the morning as given in the grove was unusually good and reflected credit upon its management, Mrs. W. W. Nelson having it well in hand. An excellent address was delivered by Judge Galloway of McMinnville, in which the spread eagle was subordinated to the thoughtful, some of our grave national problems being considered. Miss Edith McCrea won much favorable comment by the very capable manner in which she delivered Storey's oration, "Our Duty to the Republic." Two patriotic selections were sung by a picked chorus. The Declaration was read by J. C. Hodson.

The afternoon sports rather went glimmering. The McMinnville ball team failed to show up and a game was played between a couple of Newberg teams, captained by Van Leavitt and Chas. Parrett. In the evening the fireworks blazed and sputtered and sizzled until everybody was satisfied that the eagle's tail feathers were sufficiently singed. And the fun was over for another year.

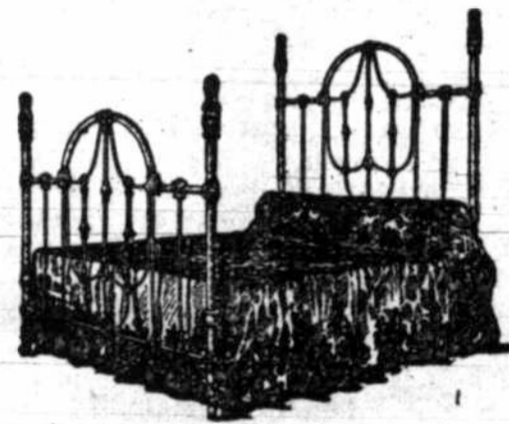
