YAMHILL FOR PROHIBITION.

Union Mass Meeting Addressed in Crater's Hall Sunday Evening by Newberg Professional and Business Men.

Yamhill county for prohibition on November 8! This was the battle cry of every one of the speakers who spoke to that big audience in Crater's hall Sunday evening. The meeting was a big success. Every speaker spoke decisively and with conviction, and new determination was awakened to carry the fight to a successful conclusion next Tuesday. The music for the occasion was furnished by a union choir, led by Prof. C. W. Kantner. In front of the singers sat the speakers of the evening.

Mayor L. M. Parker presided. In opening the service he expressed gratification at being present at a non partisan prohibition meeting. He said that if it was a prohibition party affair he would be as far away from it as (his hearers felt a panicky sensation) Brother Gould would be if it were a republican meeting—and what looked like a firebrand turned out to be a flag of truce. As prohibition has been good for Newberg, he believed it would be good for Yamhill county and was willing to see it tried for two years.

Clarence Butt ventured the opinion that the people were not there to hear good speeches, and then proceeded to entertain his hearers with one of that kind. He pictured vividly the wreck and ruin which follow in the wake of the saloon, and showed that the institution has no legitimate place in society. He gave voice to the fervent hope that every saloon in Yamhill will be swept out by next Tuesday's vote, and that our action will prove a stimulus and encouragement to others.

N. C. Christenson warned his hearers against over-confidence. From long experience he gave his word that fighting the liquor traffic is no easy proposition and that to be successful the good people must arouse themselves. "Let's free Yamhill from this curse of iniquity," was his earnest plea.

The choir sang with effect,

"Throw out the life line," which B. C. Miles, the next speaker, took for his text. He emphasized the responsibility and privilege of the elective franchise, and urged that voters weigh carefully this most important question, and cast their vote in a way to throw out the life line. The saloon was studied from the standpoints of finance, health and morals, and found wanting and Mr. Miles expressed faith in the verdict to be registered by the voters of Yamhill county.

Why should Newberg, which has no saloons, be interested in local option? J. C. Hodson propounded the question and answered the same. We have a good thing and want to keep it. We want to make it impossible for anyone to set up a saloon on the outskirts of the town. It is a further precaution for self protection. And we want to help others to a good thing. Other towns in Yamhill county are doing nothing—and the saloons are doing them. Various arguments were presented against the saloon, but his best one was the fact that Newberg's best capital lies in the public knowledge that she is the town with no saloons. This is our leading stock in trade, has brought us our present success, and we would be foolish to rob ourselves of it.

President McGrew observed that from residence in four different prohibition states he knew that to all practical purposes prohibition could be made to prohibit. He made a stirring appeal to voters to strike for the inviolability of their homes and the future welfare of the young people.

As a "first inhabitant," E. H. Woodward recited briefly the history of Newberg from a moral standpoint, told of the vigilance against the saloon from the foundation of the town, and warned his hearers against relaxation in the fight.

Sunday night's meeting was a splendid advertisement for Newberg. In no other town in the state could such a showing be made, where practically all the business and professional men can be counted on to declare themselves in public, emphatically

and uncompromisingly against the saloon and its influences. Now it is up to Newberg people to take a little trip over into Macedonia next Tuesday and help rid other Yamhill towns of the iniquitous saloon.
