With tall Timothy T. Geer in the field as a candidate for congress in the second congressional district there promises to be something doing. Mr. Geer is a great vote-getter and he would make an able, efficient representative in congress.

Superintendent H. H. Belt has issued a roster of the teachers of Yamhill county, giving the names of the teachers, the school where they are teaching and the salary paid each one, which makes a very convenient and ready reference for the public.

For neat, clear cut pages of reading matter and display advertisements that are set to stand out with an individuality that attracts the eye of the reader, the Graphic will rank with the best papers published in Oregon. The Junction City Times recently issued a special illustrated edition, setting forth the resources of the community in which it is published in a way that reflects much credit on Mr. Moorhead, the proprietor, for the enterprising spirit he has manifested in this special effort. Such an edition is always worth a great deal more to the community than it is to the publisher who assumes the responsibility of getting it out, and if the people of Lane county fail to give this edition of the Times wide circulation they will simply let an opportunity for doing some very effective advertising at a very small cost, go by, and at the same time fail to show Mr. Moorhead that appreciation which is due him for the money and hard work, to say nothing of the public spirit he has put into it.

The meeting of the State Press Association which was held in Portland on Friday and Saturday of last week, was the most representative body of Oregon newspaper men ever held in the state. The attendance was by far the best ever held at a state meeting of the press, the program was carried out to the letter without a single failure, and the vim and vigor displayed in all the sessions indicated the new spirit that prevails among the members. One of the most pleasing features of the meeting was the reception given at the residence of Dr. Henry Waldo Coe, the corresponding secretary. The election of officers resulted as follows: J. S. Dellinger, Daily Astorian, president; George Putnam, Medford Tribune, vice president; George Schibird, Union Republican, recording secretary; A. D. Moe, Hood River Glacier, corresponding secretary; Frances Gotshall, White Ribbon, treasurer. Trustees—G. B. Small, Baker City Democrat; Charles H. Fisher, Eugene Guard; C. L. Ireland, Moro Observer.

The first month of the year appears to be house cleaning time in the newspaper field, judging from the number of changes made in names as they appear at the head of editorial columns. Ex-Governor T. T. Geer retires from the Pendleton Tribune, E. R. Bradley from the Hood River News-Letter, B. F. Young from the Sheridan Sun, W. T. Fogle from the Forest Grove Times

and Miles Overholt from the Jacksonville Post. Oregon has more than two hundred newspapers published in the state, which is probably a larger number in proportion to population than are published in any other state in the Union, but newspaper plants appear to be desirable property, for they find ready sale when placed on the market. The tone of some of the Oregon newspapers would bear bracing up with something more substantial than stomach bitters, but taken as a whole they will rank well with the same number of papers published in the older and more thickly populated districts of the East.

It is with sincere regret that we learn of the death of David Brewer, the well known Indian who has held the responsible position of disciplinarian at the Chemawa Indian school for the past twenty years. Not feeling well he was given a thirty days leave of absence and he went to his home near Tacoma believing that he would soon recover. Growing worse he was removed to a Tacoma hospital where he died on January 15. In the death of Mr. Brewer the Indians of the Northwest have lost one of the most useful men of their race, for in his contact with the young men at Chemawa he wielded an influence for good that was telling for the betterment of the race in a marked degree. He leaves a wife and a large family of bright children to whom he was tenderly devoted, as well as a large circle of friends to mourn his loss, and we predict that it will be very difficult to find his equal for the position made vacant at Chemawa.

THE DEAD LINE.

A new postal regulation has been made which fixes the limit of time that newspaper publishers may extend credit to their subscribers and still retain the privilege of mailing papers at the second-class postage rate. The new regulation reads:

Sec. 446, paragraph 4: "A reasonable time will be allowed publishers to secure renewals of subscriptions, but unless subscriptions are expressly renewed after the term for which they are paid within the following periods—dailies within three months, tri-weeklies within six months, semi-weeklies within nine months and weeklies within one year—they shall not be counted in the legitimate list of subscribers, and copies mailed on account thereof shall not be accepted for mailing at the second-class postage rate of 1 cent a pound, but may be mailed at the transient second class postage of 1 cent for each four ounces or fraction thereof, repaid by stamps affixed. The right of a publisher to extend credit on subscriptions to his publication is not denied or questioned, but his compliance or non-compliance with this regulation will be taken into consideration in determining whether the publication is entitled to transmission at the second class postage rates."

The time fixed for the new rule going into effect was January 1, but the time has been extended to April 1.

From the reading of the section it will be seen that publishers of weekly papers must not let their subscribers hold back what is due them more than one year, hence all delinquent subscribers must square themselves or resort to a last year's almanac for the market reports and the news budget.

A large number of our subscribers pay each year promptly in advance, while some have asked for time and we have been lenient with them. A few others appear to be willing to take the paper for an indefinite period without offering anything in return—not even a thank you. The latter will no doubt regard the new regulation as a hardship for the ax must fall on this class of delinquents.

Statements have been sent to a number of our delinquent subscribers and others will follow as fast as we can find time to mail them. Most people are aware of the fact however if they are in arrears and they need not wait for a reminder from the office.

A Special Word.



Unless the delicate, exactly adjusted parts of a watch are kept clean and lubricated, they are certain to become worn to a greater or less extent and the movement will surely lose its accuracy. Tiny particles of grit are bound to work into the best protected movement; the oil will become gummy in time and these combined will serve to cut and grind the pivots and cause friction.

Every watch should be thoroughly cleaned and oiled at least once in eighteen months, and if yours has not been cleaned within that time, it should have immediate attention.

We will clean your watch precisely as it would be done in the best watch factories—take the movement entirely apart, clean each wheel, cog and pivot separately, assemble and regulate it—and when you get it back you may depend upon it being in "perfect shape."
