A note from S. C. Harnden mailed at Puyallup, Washington, directs his paper sent to him at that address. From this we infer that he has returned from Kansas to again locate in this great Northwest country.

J. T. Everest has disposed of his claim in Tillamook county and has bought the Woods place situated on the foothills of Parrott mountain some four miles southeast of Newberg and containing eighty acres. Of this place he is expecting to make a pretty extensive fruit and walnut ranch.
