### A Word From Mrs. Harford.

Editor Graphic:—Thinking the history of the Chehalem Center W. C. T. U. will be of interest to many of your readers, I ask the courtesy of the Graphic for space to give it at this time.

This Union was organized with five members soon after the annual state convention held in Newberg in 1896. Soon others united. Our girls became members, kept their dues paid, wore the badge and stood always for the principles that underlie this world wide organization—total abstinence, prohibition and purity. The growth in numbers has been slow at times, but continuous, and today almost every family is represented in the membership. Every effort this society has made in all these years, has been for the betterment of the surroundings of these homes, the safeguarding of the children that were in them. Many of the young people have gone to homes of their own, out into the activities of the world, grounded in temperance principles, a credit to the section in which they were reared. It has a membership of 30 active members, which with the honoraries, will keep the standard of temperance floating aloft until every saloon, gambling den and brothel is banished from our fair land.

What have they done? They have reached the public conscience by gospel temperance meetings, the emphasizing the Sunday school quarterly temperance lesson, and by bringing the best thoughts of the leading thinkers on this great question as the young people have spoken in the medal contests. They have given young and old innocent amusements, as now and then they have planned social gatherings. Instead of dances and card parties, better ideas obtain in this entire neighborhood.

And now a word regarding the organization in general. It is not a little society, measured by the few members in Chehalem or Newberg. It is organized in fifty-nine governments, the leaders in our own and all countries are women of strong religious sentiments, the ones most to be depended upon to aid in the advancement of the interests of the church to which they pay their allegiance. They are women of scholarly attainments, and are recognized leaders. If it was not called of God to do the work He has placed in our hands, it would long since have joined the hosts of forgotten organized efforts. Instead of that it is one of the most feared and dreaded enemies of the liquor traffic. Congress heeds the petitions of its 350,000 membership, as is noted in the acts of that body. ### Communication From a Farmer.

Editor Graphic:—Seeing that this year we have the privilege to vote on a law to amend our present system of taxation the question naturally arises whether or not our laws need any radical changes.

No one has any doubt but that our present system could be greatly improved upon and while it will be difficult to make laws that will not find opposition yet a law which will hurt the producing class would be unjust and should be relegated to the rear.

Whether all believe it or not the farming class are the hardest worked and heaviest taxed of any class of individuals and the farmer has no voice in what shall be the price of his product, nor the price of what he pays for articles he has to buy; but as sure as the result of the Silent Reaper he pays the bulk of the taxes and the result of his toil furnishes the life for the masses. He does not strike either for better pay or an eight or ten hour day; but he is always plodding away and as he does not make much opposition to conditions as he finds them, he finds too often to his sorrow that his law makers are willing to put their burdens on his shoulders also. And now in regard to the single tax. If he does not look out he will be buncoed into believing it is gotten up for his especial benefit, and not for those who already have too many favors given them in the shape of protection and often bonuses from his pocket direct.

While large holdings of land do not add as it should to the general prosperity yet a tax on it only could not bring about the time when all things have worked out for the good of all, no more than our present system of taxing all standing timber fifty cents per thousand will allow an extra tree to stand and grace the hills and valleys of Oregon, outside of the wise provision of our government for the protection of its timber in its mountain ranges.

We know that so much for taxes is required or is collected whether judiciously expended or not, and from whence will come the taxes for the millions of money invested in manufacture, railroads, etc., and why the justice of exempting them from taxation and putting it only upon the land? We all know our taxes are high enough already and we
