W. C. T. U. meeting at home

back of the city hall and fronting
on Dayton avenue.

C. Marsh has traded thirty
acres of the east part of his place
located a mile out on the road
to West Chehalis to Wm. And-
rews who was over from Van-
couver a short time ago looking
for a location. In the trade Mr.
Marsh gets some Vancouver
property.

Fred Hutchens' driving horse,
while hitched to a cart and
standing outside the college cam-
pus Monday afternoon, became
frightened at a gun fired by one
of the boys in starting races on
the track and took a spin around
town and out on the Portland
road to his home a mile and a
half east of town without doing
any damage to the rig.

As a result of the big horse
sale held in Portland last week
Newberg has some new equine
blood that will no doubt exert
an influence on the driving horse
of the future in this community.
C. C. Ferguson purchased a three
year old black stallion, General
Jones, No. 41747, a brother to
Belmont 2.09 1/4 and bred by J.
A. Jones, of Springbrook. He
is a trotter of fine style and good
action and is a beauty. J. D.
Gordon also was the successful
bidder on Sovran No. 44275, a
bay stallion three years old and
bred by C. X. Larrabee, of
Brook-Nook Rancho. This is a
well bred horse and he will no
doubt make his mark. Both
these fine young stallions may
be seen in Newberg.

David L. Baker, who came
from Montana last October and
bought a small place out in the
Springbrook neighborhood, was
in town Tuesday expressing re-
grets on account of having an-
swered an advertisement in a
matrimonial paper some time
last year, the correspondence fol-
lowing resulting in marriage.
The name of the woman who
figures in the affair was Mrs.
Willis and she formerly lived
about McMinnville. Mr. Baker
says he sent her money with
which to pay her railroad fare
and she went to him in Montana
where they were married. In
October they came here as noted
above, he having a child two
years old by a former wife and
she a daughter of probably four-

His story is that all went well

Following this decision Mrs. B.

he was required to put up a bond

The old A. R. Burbank prop-

was partially covered by insur-
ance. This location is one of the
