ESCAPADES OF OUR GOVERNOR.

The attention of our readers is called to a letter which appears on the first page, written by a woman to the Oregonian in which she tells of the conduct of the Governor of Oregon while attending the recent regatta at Astoria.

This is the "good fellow" who by the aid of democrats, republicans, prohibitionists and such municipal reformers as Rev. Clarence True Wilson, of Portland, was given a majority of votes at the June election for United States senator. This little escapade at Astoria which horrified the woman who saw him, was tame when compared with others he is openly charged with.

During the campaign the Graphic took occasion to call the attention of the voters to some of these disgraceful acts of the Governor, believing that they were entitled to know the truth. So far as we know no other paper in the state ventured to tell the voters of these things. Some of them in their endeavors to hide the truth said the Graphic was engaging in "mud slinging." You can be sure of this one thing. The Graphic never slings mud unless the other fellow furnishes the mud and the conduct of the governor of a state as hemingles with the people should be an open book. An act of his that would dam a hod carrier in the eyes of the people, may be condoned by some newspapers but since our Governor persists in making a spectacle of himself before men, women and children on railroad trains and at various public gatherings, the Graphic takes the view that its readers are entitled to the information.

The conduct of the governor of a state should be an example of propriety before the people and when he goes so far in the other direction that his escapades become notorious, the time has come when the matter should be "hushed up" no longer.

It is unfortunate for Newberg that Mr. Bussell has not seen his way clear to operate his canning plant here this season. He sent some of his experienced help here several weeks ago and evidently expected to begin business but it appears he loaded up so heavy last season, with the change in financial conditions immediately following, that he has not been able to operate his new plant here. It has been a disappointment to many of our growers who have been handicapped in attempting to dispose of their stuff at a profit, but it must be admitted that Mr. Bussell has shown his faith in Newberg by erecting one of the best canning plants here that there is in the Northwest, and the sudden change in business conditions which wrecked the plans of many financiers could not be foreseen. The plant will be operated in the future, beginning next season without doubt.

The Oregon Agriculturist says: "The sudden and effective manner in which the agricultural college men have taken the wind out of the fictitious claims put forward for Alaska wheat is refreshing. The foundation had been laid for gulling a multitude of people into paying fancy prices for an article of doubtful value, but those who now get fooled will be the kind who depend on the Saturday Evening Post and similar purveyors of agricultural fiction for their agricultural news and from

the standpoint of an agricultural paper such persons ought to get taken in occasionally."

Get away from business a few days next week and attend the state fair. There will be a fine exhibit of the products of Oregon soil and the stock show will be fine. And then it is profitable to get away from home and mingle with people from all parts of the state. Such contact tends to broaden ones view of life.

The Prohibition Speech

Eugene W. Chafin, the presidential nominee on the prohibition ticket, spoke to a good sized audience in the Edwards grove on last Friday morning, made up of people of all shades of political faith. He came by auto from Portland and as the party was an hour or more late in arriving he was compelled to cut short his speech in order to get in his appointment at McMinnville.

The band was out and assisted in entertaining and holding the crowd while the speaker was being waited for.

Mr. Chafin is a man of very pleasing appearance and address. He is a forceful speaker and from his standpoint makes a good talk. His style is just the opposite of that of the prohibition speaker of former years whose efforts were largely spent in an endeavor to jab his theories down the throats of his hearers, regardless of what they might think about it.

It was noticed too that he left out the old phrase that was formerly in evidence among the ultra followers of the faith,—"Don't see how any Christian can vote any other than the prohibition ticket." His style is argumentative and commanding and whether you agree with him or not you must admire the man if you hear him.

His weak point is in attacking local option when it is sweeping the country for the annihilation of the saloon as no other movement ever has, and it is the one movement that is scaring the life out of the liquor dealers.

New Feature at State Fair.

The "Dairymen's Headquarters" will be a new feature at the coming State Fair. It will be supervised by the State Dairy & Food Commissioner, who expects to make it a bureau of general information, where Oregonian and outsider are alike invited to go and learn what is being done along the line of dairying in Oregon.

A deputy will be present at all times to answer questions and give information; dairy authorities will speak each day; there will be charts showing the results of cow testing work now being carried on in Oregon; the use of the Babcock test will be explained and demonstrated; the acidity test for determining quality of cream will be applied.

There will be seats provided so that it will be a resting place as well as a place of instruction. Dairymen are invited to make it headquarters while on the grounds. You will meet fellow dairymen there and see and hear things both interesting and instructive.
