DO YOU APPROVE OF BUSINESS ENTERPRISE?

Perhaps there are times when you feel that some of the business men of the city are not progressive enough. Ingrained in your nature is an admiration for the "hustler" for the person who does things—who improves whatever he touches.

You admire the merchant who, in brief space, takes a moribund store and makes it glow with life—a credit to the city. You are sure that if we had more such men the city would benefit amazingly.

A careful observer once noted the coincidence that most large cities are located on the banks of rivers. It is equally certain that most large stores happen to be enterprising advertisers.

In fact, aggressive advertising is the one infallible test of enterprise in a merchant. It stamps him progressive—alive—wise. All other "signs of life" about a store are misleading if a store is not aggressively advertised. The merchant knows this.

This editorial is to urge all those people who believe in progressiveness, in enterprise, to be consistent—to patronize the progressive and enterprising stores. The safe test is the store's advertising. You can buy advertised things and know that you are helping to make enterprise worth while—and know, too, that you are saving money for yourself. You can buy of the non-advertising merchant if you want to encourage and reward non-progressiveness in business, as well as to run the risk of securing for yourself a very doubtful bargain. Progressive people should patronize progressive merchants.

Since the close of the State Fair a good many suggestions have been made as to the improvements that should be made before another year, both by the fair management and the city of Salem. The toilet accommodations on the grounds are miserable makeshifts and a disgrace to the management and should be replaced by decent, modern equipment. A splendid grand stand has been provided for those who want to see the races but no accommodations at all have been provided for people who want to see the stock as it is being judged. A show ring should be enclosed and seating accommodations provided for the people. In dry weather, such as prevailed this year, the parade ring should be sprinkled in order to keep down the dust. During the fair this year the management seemed perfectly oblivious to the fact that the stock were stirring up great clouds of dust that settled over everything about the grounds. All these years thousands of people have, day after day, passed from the entrance to the grounds as far as the Fair Grounds postoffice, being compelled to walk in the middle of the street, which is often crowded with teams, or on the car tracks, there being no sidewalk of any kind provided. The street is rocky and rough and women and children are constantly in danger of injury from passing teams or electric cars. Almost any other village in the country would have provided a walk at that congested spot long ago. Salem should awake from her slumbers. That is the ideal place for our State Fair but the city should begin to show some commendable zeal in the matter of civic pride in the region of the grounds, a discrepancy having been much in evidence in the eyes of outsiders all these years along these lines.

Voters who registered previous to the June election need not register again in order to vote at the presidential election, but all others, although they may have sworn in their votes at the June election must register if they want to avoid a repetition of the swearing in process. R. B. Linville is prepared to register voters. Do it now and avoid annoyance and delay in voting on election day.

Senator Beveridge, of Indiana, is to speak at the Armory in Portland on Tuesday night of next week when the republican campaign will be opened. Beveridge is one of the best campaign speakers in the field and since there are more native Indians about Newberg than can be found in any other community in Oregon, we ought to send a Hoosier brigade to Portland to attend the speaking.

The lack of interest on the part of the Portland people in the big stock show held in that city last week, as shown by the meager attendance, did not furnish much ammunition for the hinted proposal to try to get the State Fair removed from Salem to Portland.

It is surprising to note the non-partisan spirit manifested by the Portland Journal as the campaign advances. Whether or not republicans continue to gulp it down as many of them have done in the past remains to be seen.

The way the high up fellows in the two great parties are beginning to warm up to the subject indicates that there is likely to be something doing yet before the date of the November election.

This is going to be a mighty hard season on short length church goers. Think of those two story hats.

Juvenile Court Report.

The report of the Juvenile Court of Multnomah county for the year ending June 10 is at hand, and although quite brief makes interesting reading.

Of the 786 children brought before the court 532 are reported to be children of "capable parents," while 13 are of vicious or immoral parents, 191 from incompetent or careless parents, 39 of intemperate father and 12 of intemperate mother. Why such a large per cent should come from the homes of "capable parents" is a question left for the reader to solve. Of the mental condition of the children 737 are reported as normal, 16 defective and 33 perverted. Causes of dependency, poverty 12, desertion of parents, one or both 25, immorality, drunkenness, cruelty or wilful neglect of parents 44, insanity of one of the parents 12, other causes 78. Of the whole number brought before the court 610 were boys and 175 girls.

The various charges for which the delinquents were brought into court are given as follows: Burglary, larceny, assault and battery, immorality, violating state laws, violating city ordinances, violating school law, persistent truancy, malicious mischief, growing up in idleness and crime, disorderly conduct, destroying property, incorrigible, cigarette smoking, drunkenness and other causes.

In the report fulsome tribute is paid to Judge Arthur L. Frazier, the first judge of the court, who died during the year, and proved himself to be eminently well fitted for the position. The report is made by Judge C. U. Gatenbein who now holds the place.
