J. J. Woods Deceased.

After an illness of three weeks city marshal, J. J. Woods departed this life at his home in the east part of Newberg, Tuesday, April 19, at the age of 61 years. The deceased was born at Charlottsville, Indiana, October 11, 1848 and on November 20, 1873 he united in marriage with Louisa Nicholson. In 1879 they removed to Oregon, first locating near Dayton but later coming to Newberg which has since been their home.

The deceased was one of a family of ten children and an older sister, now the only surviving member of the large family, was at his bedside at the close. For many years the deceased has served the city of Newberg as marshal and at different times has given faithful service as constable and deputy sheriff.

He leaves a widow, three daughters, the Misses Ida, Ione and Merle, and one son, Roy Woods, all of whom reside in Newberg. The funeral is being conducted this Thursday afternoon at the Friends church as we go to press.

Novel Use of Paper.

Germany manufactures annually 425,600 tons of paper; England, 260,000 tons; France, 190,000 tons; Austria 155,000 tons, and Italy 120,000 tons. But the United States makes and uses more paper than all Europe, the annual production amounting to 1,300,000 tons. A French journal mentions the following novel use of paper in America:

Roofs of paper and compressed wood pulp have proved successful. A Chicago firm makes paper garments which are light, flexible and convenient. The paper is made of the bark of the paper mulberry tree, and is tubsized and finely scraped. Several sheets are superposed and sewed together. The garments have narrow wooden bindings, buttons, button-holes and other fastenings.

Paper bottles and grain bags are made in Philadelphia. A recent invention is the paper horseshoe, which according to the inventor, is more durable as well as lighter than the iron shoe, and is attached not by nails, but by cement. Two German engineers have invented a sort of a reinforced paper, composed of paper pulp, canvas, linen and raw silk, re-enforced with steel wire. The new material is light, water-

Prominent Railroad Man in Town

J. G. Gage, Traffic Manager for the Lake Shore & Michigan Southern railroad, with headquarters in Cleveland, Ohio, arrived here on Friday evening of last week in company with Mrs. Gage in his private car, and remained over until Tuesday, visiting in the meantime with their son-in-law and daughter, Mr. and Mrs. C. R. Duer, at their new home two miles out on the West Chehalem road.

Mr. Gage has spent practically all his life in railroad work and has seen a great deal of country, and it is gratifying to hear one of his mature judgment speak in the glowing terms he uses in giving expression to his opinion of our country. Both were so well pleased with their visit and what they saw that Mrs. Gage anticipates making two trips a year to Newberg, while Mr. Gage says he will look forward to the termination of his service with the railroad company a few years hence with a great deal of pleasure, when he will make this his home.

Quickest Run of the Express Pony.

The first run of the pony express was made in ten days, and the enterprise was hailed with delight by citizens, though it never paid one tenth of its cost. The promoters simply carried it on until the first transcontinental telegraph was finished, eighteen months later, in the belief that the pony express would lead to the award of large mail contracts for stage lines later on—a belief which proved well-founded.

The quickest run ever made by the pony express was when Abraham Lincoln's first inaugural message was sent from St. Joe to Sacramento in seven days and seventeen hours. The first rider out of St. Joe at that time was W. J. Cates, now a resident of Denver.

"I remember when the superintendent rushed out where I was standing by my horse, ready for the start," said Mr. Cates. "He was white with excitement. 'Ride as fast as you can, young man,' he said as he locked the pouch, 'because President Lincoln's inaugural message is in here.' It was a cold, gloomy day in March, and the going was none too good, but I never made such good time, nor quicker changes at the relay stations."—Arthur Chapman, in May Pacific Monthly.
