



CHAUTAUQUA PROGRAM

Management of Willamette Assembly Gets Finest Talent Obtainable.

What promises to be the most successful chautauqua of the Willamette Valley Assembly will be held at Gladstone on July 4 to July 15 inclusive. All arrangements have been made for the chautauqua, and the best lecturers, singers and other entertainers that it is possible to obtain have been engaged. Copies of the program which contains thirty-one pages, have been mailed to 10,000 persons in this and adjoining counties, and other persons who desire programs, may obtain them by applying at the Young Men's Christian Association and J. K. Gill's bookstore in Portland, and Huntley Bros. drugstore and the First National Bank in Oregon city. One lecturer, Senator Borah, of Idaho, was obtained after the programs were printed. He will speak on July 8, and a large crowd is expected to hear him.

PROGRAM REPLETE WITH "GOOD THINGS."

The program is so replete with "good things" that it is almost impossible to epitomize it, and deal fairly with all the speakers and artists who have been engaged. On opening day, July 4, all Grand Army veterans, wearing the Grand Army button will be admitted free of charge. There will be a game of baseball in the morning between "The Teachers" of Clackamas county, and "The Blackstones," a team made up of lawyers, physicians, ministers and dentists of the county.

The afternoon's entertainment will consist of a concert by the naval band, music by the G. A. R. Drum corps, "The Star Spangled Banner," by Rose Bloch Bauer, reading the Declaration of Independence, "The Evolution of Patriotism," by ex-Governor Yates, of Illinois, baseball game between semi-professionals, racing, games, etc., and at night there will be a concert by the Naval Reserve Band and a lecture by Dr. Gabriel R. McGuire, entitled, "With an Irishman through the Jungles of Africa."

MRS. FOX TO LECTURE.

While the program will be somewhat different the second day, it will be just as interesting as that of the first. The leading events will be scripture reading by Rev. Edith Hill Booker, a lecture on Parliamentary Law, by Mrs. Emma A. Fox, band concerts, lecture by Dr. McGuire on "An Irishman's trip through Europe," baseball and a dramatic reading, "The Melting Pot," by Mrs. Lula Tyler Gates.

July 6 will be Scotch day, and there will be bagpipe music, Highland dancing, songs and recitations, including "Bobby Burns" by Hon. Wallace Mc-Camant, Portland. Mrs. Delphine Marx, the famous contralto will sing and Lulu Tyler Gates will give a reading "Polly of the Circus." There will also be baseball games, band concerts and selections by the Apollo Concert Company of Chicago.

Among the features of July 7, Club Day, will be a solo by Miss Maud Dammasch, an address, "The Scholarship Loan Fund," Mrs. Frederick Eggert, an address by Mrs. S. M. Blumauer, council of Jewish Women and an address on "The Press and the Club Women" by Mrs. L. T. Hidden, Oregon Press Club. There will be concerts by the

Apollo Concert Company, musical selections, addresses by Mrs. Emma A. Fox and W. A. Williams, baseball game and a lecture "The Spirit of Democracy," Governor J. Frank Hanley, of Indiana.

JULY 8 IS BOYS' DAY.

AMER. WOMAN'S LEAGUE

Defense of E. G. Lewis and the League by one of its Members.

A matter of such wide spread public interest as the American Woman's League needs no apology for trespassing on the space of our local press—valuable tho' we realize that space to be.

As most of us know the "Oregonian" recently gave its first column, and more to the publication of a virulent attack on the league, its methods, and pre-eminently against its founder, Mr. E. G. Lewis, mayor of St. Louis, Mo. A few days later it again opened its columns (this time in the editorial pages) to a lengthy article attacking more bitterly than before the character of Mr. Lewis and the feasibility and honesty of the league program.

There are two points here that claim attention; first, that the later article was an excerpt from the "Rural New Yorker," a paper that has been sued for libel by Mr. Lewis and second, that the previous article was evidently inspired by Claude D. Hall, the attorney for the above paper into whose hands it has been urging its readers to put their notes and other indebtedness they may hold against the league and its affiliated interests. That less than two per cent of the total claims have been turned over to them, while over eighty per cent have been turned over to the re-organization, which is now in charge of all the league interests, speaks for itself.

The truest gauge we can take of the character and reliability of an organization, as of an individual, is that of the friends and enemies they make. Any individual or organization that has grit and purpose enough to manfully strive for its ideals, is sure to have enemies. The character of its enemies is the revelation of itself. The same rule holds in regard to its friends.

There is not space to go into the details of this fight, first of an individual and through him of an organization set to secure the broadest possible opportunities, and the fullest development not only for city women, but for the rank and file of American womanhood; the grittiest and most gifted of whom are often to be found in our rural districts—undeveloped—unconscious of the powers lying dormant within them; conscious only of a yearning and craving within for they know not what—that they can never hope to satisfy save by some such organization as this American Woman's League, which aims to—and will if it is not thwarted by selfishness and malignity—bring the culture of the cities within the reach and means of the brave women who on thousands—nay millions—of farms wage constant battle against isolation, lack of opportunity and mental starvation.

Who are the enemies of this great ideal? Goodwin! Cortel-you! If their names do not recall their history in this connection, ask about them, I have not space to more than name them here. Then on the floor of the Senate when Senator Jeff Davis of Arkansas so bravely and adequately championed the cause of the E. G. Lewis concerns against the injustice of which he had been the victim, the opponent raised was Senator Burton of Ohio who though no one questions his personal integrity, was so evidently used as a "cat's paw" and posted on what to say, that he was led to make many statements that

were absolutely incorrect—e. g. that the league had "no capital, no funds, and \$2,000,000 in debt" when "the actual facts"—says Mr. Herbert Hungerford, of whom more anon—"are that the league has practically no debts other than meeting of current expenses, and whose assets in pledges from the membership dues above amount to over \$800,000." Later in his speech he spoke of the league membership as mainly being drawn from "servant girls, washerwomen, and boarding house keepers!" Educational and Art courses do not usually prove highly attractive to this class of people! Again I would ask that those who give credence to these detractors will inquire for themselves what class of women they are who are foremost in league work? This thing is not hidden in a corner; its women—of state and national reputation, are too numerous even to be mentioned here.

Then last amongst the enemies of the league; most malignant and unscrupulous, and, as is often the case, also the most insignificant and despicable, is Claude D. Hall, the attorney for the "Rural New Yorker" the framer of that wonderful bill in Equity filed in the U. S. Court of St. Louis, Mo. against the various companies included in the league reorganization. This precious document, "was shown to several of the ablest lawyers in St. Louis, who without exception laughed uproariously over it and refused to give any further opinion on it than saying it was a huge joke." (Herbert Hungerford.)
