CIRCUIT COURT

Judge Kelly Winds Up Long Docket At McMinnville

Judge Kelly began early on June 3rd, to finish up the longest docket in the history of Yamhill County. The first case called was that of F. H. Ide vs. Sheridan Lumber Co., W. C. Winslow and C. L. McNary for the plaintiff, and W. O. Sims and McCain, Vinton and Galloway for the defence. This case was based on a certain fire alleged to have occurred on the plaintiff's land due to a defective spark arrester on a donkey engine of the defendant's lumber company, whereby it was alleged that several million feet of lumber on the plaintiff's land was destroyed. After a strong battle lasting over two days, the jury brought in a verdict for the sum of \$4000. The verdict was a big surprise, as the amount sued for was only \$5000. It was understood that a compromise was offered by plaintiff but rejected. To make matters worse, it is rumored that this is only a test case, there being several of like nature. Evidently, the defence was of little avail.

The next case was that of the longest battle in the legal line for years, lasting four days. J. A. Hewitt and his wife, Mary J. Hewitt, each brought separate claims for damages against the County of Yamhill by reason of the opening of a certain road through the premises of each of them at Unionvale and on what is known as Whidby's Island in the Willamette River. This island is about four miles wide and six miles from north to south and has no outlet. Mr. Hewitt claimed damages in the sum of \$2600 and Mrs. Hewitt in the sum of \$1750. The two cases were consolidated and tried as one. The jury brought in a verdict for \$145 for Mr. Hewitt and \$270 for Mrs. Hewitt. Attorney W. M. Ramsey and ex-Judge Henry Hewitt of Albany appeared for Mr. and Mrs. Hewitt, while B. A. Kliks appeared for the County and petitioners. The small verdict was a surprise, coming as it did from the same jury that rendered such a big verdict before. The defence was strongly maintained by the people from the Island. The Hewitt's land is crossed for something more than one and a half miles and is cut in two, but the road is a great deal of a benefit to them, the county claiming that it really benefits a great deal more than it injures.

While the jury were viewing the premises in the Hewitt case, another special jury was picked from McMinnville and vicinity for the case of Dr. Andrew Kershaw, former Indian Agent and Willamina capitalist, against Morris Dudley, over the sale of a quantity of hay. Attorney B. A. Kliks appeared for the defence and W. O. Sims of Sheridan for the Doctor. The trial lasted all day, and the jury brought in a verdict for the defendant. This is the second case between the same parties, and with like result. It makes the third case the Doctor has lost this term, in which the same attorneys appeared, and the fourth time in which the same attorneys have appeared against each other, Mr. Kliks winning all of them.

Besides these jury trials, Judge Kelly took up a number of motions, demurrers and ex-parte matters. The most important of the latter class was that of the Chinese cases against W. G. Henderson, Mr. Kliks filing a cost bill in the sum of \$430. A fight over these costs is made, the parties backing the sheriff claiming that the costs ought not to be allowed in excess of \$240. The docket is now clear of all cases that are for trial, but already several criminal matters are up for the next term of court, besides several civil matters.

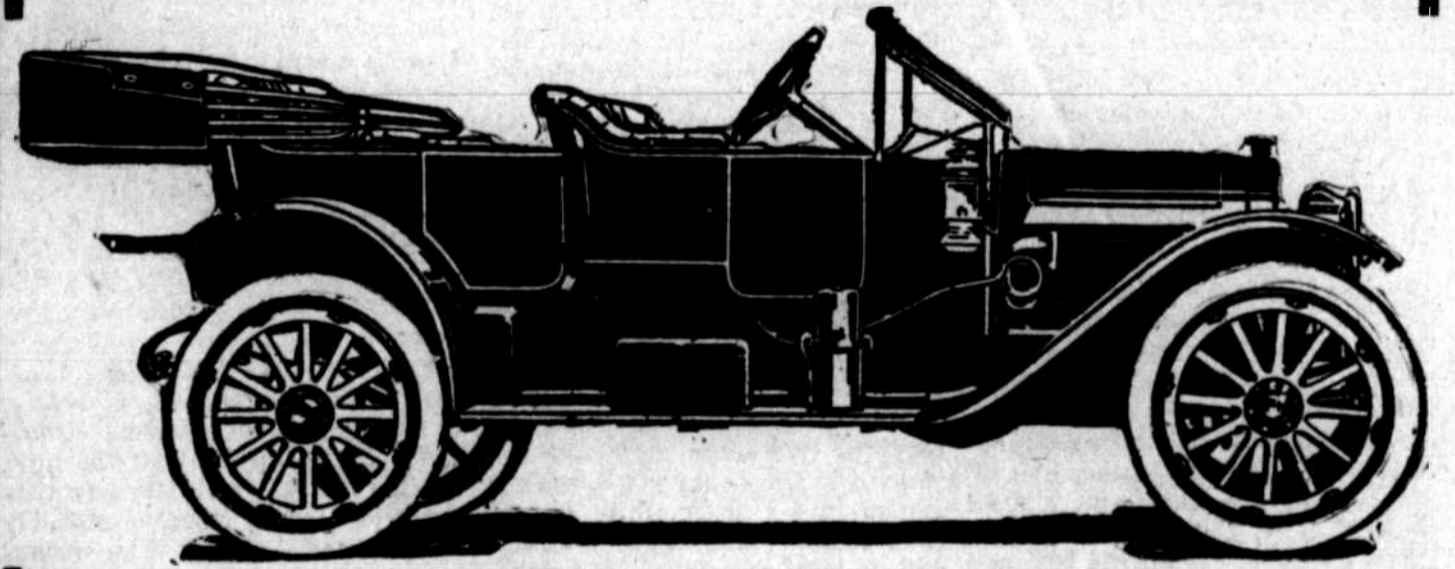
