The new franchise is not materially different from the old one, except that it is stipulated in the new one that the Yamhill Electric Co. shall pay to the city, on or before the fifteenth day of January of each year during the life of the franchise, a sum of money equal to one per cent of the gross earnings of the company, in excess of \$10,000, from rates or tolls collected the previous year. The company has in contemplation some material changes in street lighting that will greatly improve the service.

NEW GLOVE FACTORY

After several weeks delay, occasioned by his failing to get stock from the East, owing to strikes, K. W. Shafford started the wheels to going in his canvass glove factory at 806½ First street, the first of the week.

Two machines, operated by women and propelled by an electric motor are in operation to begin with, and as Mr. Shafford feels his way, other machines will be installed as the business expands. Beginners turn out ten to twelve dozen pairs of gloves a day, and as the operators become more efficient they will run out fifteen or more dozen to the machine in a day.

At present the patterns are bought in the East already cut, but later Mr. Shafford expects to get a die and do his own cutting.

Every small industry that can be run at a profit is a benefit to a town and Mr. Shafford deserves the encouragement and support of the business men of Newberg who buy gloves of this kind. There is a growing demand for cheap canvass gloves, as they cost but little and are worn by everybody who wants protection for the hands while engaged in out door work. This new industry for Newberg ought to grow into a business of no small proportions.
