Last week the Sherwood News-Sheet began the new year of its existence. It's a dandy little paper and the people of Sherwood should feel proud of it. E. O. Shepherd, the publisher, intends making it eight pages in a few months.

Some fellows are worrying about whether the Oregon Electric track, now laid to Main street, will end at this point, and if not, how they are going to get out of town up the valley. Say, fellows, don't worry any more, for the Hill road is one that "does" things. You remember how rapidly their track and pavement was laid, and such a substantial and beautiful piece of work the people are still talking about it. Well, that industrious bunch will be in Newberg again one of these days and have us connected up at both ends of First street before you realize it.

The most inconsistent proposition for advertising in the Graphic came to hand this week from an eastern patent medicine firm, enclosing proof sheet of reading notices (which measure up \$1.00 per week, to be changed monthly) and their contract all filled out ready to be signed and returned, in which they agree to pay \$6.00 for running their ads in this paper for one year. But the whole smear went into the waste basket, just like many other propositions of like nature from firms who offered to pay near the regular rates, simply because the Graphic readers don't like to see medicine ads in the paper, as it don't deal in that class of reading matter, and as long as it is clear of such an imposition on its subscribers, it's a lead pipe cinch it ought to stay clear. As a general rule the people don't like to see "med" readers sandwiched in on the news pages, but that is just what a majority of their contracts call for, "top of column or next to pure reading matter," and those with catchy single or double headings a person reads half of the ad before they become aware that it isn't a news item and remark: "Those medicine ads always fool me." The Graphic's classified page, where all pay notices and liners appear, has been established for years and the readers know they are always there and don't have to read the whole paper over to find all that belongs in that depart-

ment. The same with the locals and personals, editorials and miscellany, all have their places. And remember, instead of getting from a half column to two columns of "top of column or next to pure reading matter" slush, you get that much more space filled with pure readable matter in the Graphic. If those concerns would run display ads like other business firms do and let them be made up without giving them an edge on local advertisers, it would be different. But they want the earth.

OBITUARIES

Cook

Martin Cook, son of John and Anna Cook, was born in Marion County, Indiana, 10th month, 30th, 1832, and was a birth-right member of the Friends Church. At the age of eighteen years he moved with his parents to Warren County, Iowa, and three years later, on 5th month 11th, 1853, he was united in marriage to Mary Jane Smith, according to Friends custom, at Middle River Monthly Meeting. To this union was born nine children, one dying in infancy.

They moved to Dallas County in 1854 and were among the first Friends in this locality, Bear Creek Meeting being organized and held in their home previous to the building of a meeting house.

In 1868 they moved to Earlham, the first railroad town in Madison County, and he was the first station agent in the place. He was active in the establishment of a Friends Meeting in this place and was converted in a mid-week meeting about the year 1869.

In 1872 he moved with his family to Lyon County, and they were the pioneer movers in the establishing of Dale Monthly Meeting. In a revival meeting held in this place by Jesse and Eliza Kenworthy and F. M. George, he received the blessing of sanctification and began at once to exercise his gift in the ministry and was recorded a minister of the gospel in 1879 by the above monthly meeting. He felt a deep concern for isolated Friends, and in 8th month, 1882, he was liberated by his monthly meeting to visit meetings and families in Kansas, Nebraska and Arkansas. He started on this visit two months later, accompanied by his wife and one son, in their own conveyance and at their own expense. They traveled six months, visiting in the love of the gospel meetings and families of Friends and others.

In 1886 he moved to Newberg, Oregon, and was active in the establishing of the Yearly Meeting. He was actively engaged in the work of the Church until his health failed six years ago. He served as pastor at Middleton, Sherwood, Dundee, Chehalis Center, and Alder, Oregon, and attended every Yearly Meeting except the last two.

He had a special interest in and love for children and held many children's meetings.

For the past three years their home has been in Portland, where his faithfulness in the attendance at meeting and kindly greeting won a warm place in the hearts of a large circle of friends.

For several months he has been confined to the house on account of failing health, but through all his sickness manifested a most cheerful and patient spirit.

He peacefully fell asleep in Jesus on 9th month, 30th, 1912, at the age of seventy-nine years, eleven months and ten days.

He is survived by Uriah Cook, of Everett, Washington, an only brother, and leaves a wife and four sons, B. S. Cook and J. A. Cook, of Portland, J. H. Cook, of Ontario, Oregon, and Alvin W. Cook, of Colville, Washington, and three daughters, Mrs. Lydia C. Gardner, Portland, Mrs. Anna Miles and Mrs. W. G. Allen, of Salem, with twenty-

one grandchildren and five great grandchildren to mourn their loss.

Appropriate funeral services were held in the Friends Church at Newberg, conducted by Lindley A. Wells, of Portland, his recent pastor, assisted by Rev. Herbert Cash, of Portland, a former pastor. The music was furnished by a quartet of the Newberg Church. Interment in the Newberg cemetery.

SCHOOL NOTES

Protests have been received at this office against apportioning High School funds for pupils who are attending High School outside their residence districts. Paragraph 306, page 118, School Laws of Oregon, which governs this matter, reads as follows:

"Paragraph 306. Pupils must complete course in residence district. No tuition shall be paid for a High School pupil to any district, except to the district in which his parents or guardian shall actually reside, during the time of said pupil's attendance in such district; provided, that tuition may be paid for a High School pupil to a district other than his residence district if the High School is not in session in the residence district of such pupil; or if such pupil has completed the course of study offered in his residence district; or if he has obtained the consent of the county high school board to attend school in a district other than his residence district. (Lord's Oregon Laws, paragraph 4189.)"
