Plans are now well under way for the holding of the seventh annual boys' conference at Eugene, November 29 to December 1, the Friday, Saturday and Sunday following Thanksgiving day. At a meeting of representatives from the University of Oregon, the Eugene Commercial club, the Ministerial association, the U. of O. and the city Y. M. C. A.'s arrangements were made for the entertainment of the two hundred delegates that are expected to attend this conference.

From the time of the holding of the first conference at Salem in 1906, these gatherings have been growing in size and interest till today they stand as the greatest influence for the betterment of the boyhood throughout the state of any movement of its kind. Open to delegates from any organized Sunday School class or Boys' Bible Study club whose members are of an average age of fourteen years or over, these conferences have been the means of bringing together boys from the entire territory from Portland to Roseburg, and this year it is more than probable that there will be representation from Grants Pass.

Entertainment is furnished free by the citizens of Eugene and special rates are to be made on all the roads so that the expense item is brought to a minimum. H. A. Dalzell, the state boys' work secretary, will spend his time between now and the date of this conference working up interest by visiting as many of the larger towns as his time will permit, and in perfecting the program. He will gladly send programs and printed matter regarding the conference to any who drop him a card care of the Y. M. C. A. building, Portland.

Already the program committee has secured promises from H. W. Stone, R. R. Perkins, of Portland, A. C. Schmitt, of Albany, to be in attendance and to take part on the program. They are hoping to have W. H. Lewis, of the Lewis-Wiley Co. of Portland, deliver the opening address of the conference, "Progress and Success."

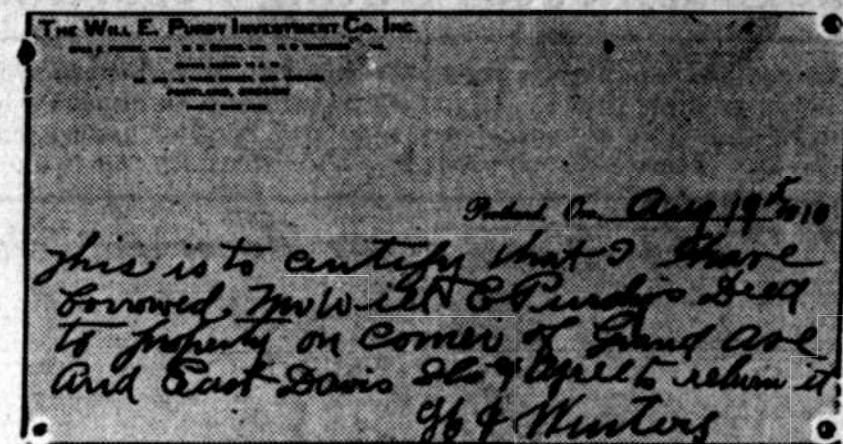
