February, though the shortest month in the year, is crowded with events. The twelfth is Lincoln's anniversary, the fourteenth is valentine day and the twenty-second is Washington's anniversary.

Notwithstanding the fact that the groundhog is supposed to be holed up for six weeks, the season is at hand when the shrubbery and fruit trees should be pruned and the eggs put under the hens, if early fryers are wanted.

A Marion county farmer named I. A. Rondeau, who had been drinking, left Woodburn for home, walking the railroad track. He was struck by the Shasta Limited and instantly killed, leaving a wife and four children. Doubtless he belonged to the manly class of fellows who can drink or let it alone.

Hard surface paving comes high to the property owner to be sure, but it is a good time now to note the difference between hard surfaced streets and those that are not thus improved. There are certainly none who would want to see First and Main streets put back in their former condition.

A fire insurance bulletin makes the statement that in Berlin every fire is held to be criminal, either by intent or negligence. The police carefully investigate every fire, and the responsible person pays the cost of putting out the fire and damages besides. The result is that in Berlin the average annual fire loss is \$300,000, while in Chicago, a city of about the same size, it is \$6,000,000.

The people of Carlton who put up a stiff fight for a dry town in the city election held last Monday, are to be congratulated. Two tickets were put up and the issue was clearly drawn, wet or dry, and the dry forces won. The majority of the voters of Yamhill cast their ballots for a dry county when the question was voted on and Carlton has decided to stand with the majority.

The political gossip just now is that Senator Chamberlain is to have a place in the cabinet of President Wilson and that West is to resign as Governor, letting the office go to Secretary of State Olcott, who is to appoint West to the vacancy made in the senate by the resignation of Chamberlain. What a lot of slates of this sort of making will be smashed within the next six weeks.

The Hoskins' temperance bill passed the Senate with a good majority, and although the saloon forces are storming the House, it will no doubt pass that body easily and will receive the Governor's signature. This is one of the most far reaching temperance measures that has ever been before the legislature, aside from straight prohibition, as it will shut out cross roads grog shops and road houses. No saloon licenses can be issued outside incorporated towns.

An Eastern archaeologist has it figured out that one Cain, son of Adam, deceased, fled to the "Oregon country" after the family trouble and took up his abode about Klamath Falls. Had he stated that the Willamette Valley was the site of the original Garden of Eden, no one would have been surprised.

Portland architects say the outlook for building in the city the coming season is very promising. Besides the usual number of big business houses, many expensive residences are being planned and an active building season is expected. The excavation work for several sky-scrapers is already well under way. Portland is easily leading the Northwest in substantial building and is destined to be a great city.

The Woodburn Independent has not furnished the information asked for by the Graphic in order that a fair comparison might be made between the Woodburn and Newberg public school indebtedness and operating expenses. The Independent recently gave a statement of the bonded indebtedness of the Newberg school district and attempted to make capital for Woodburn by stating that although that city was about the same size as Newberg, the school district had no bonded indebtedness. In last week's issue of that paper we notice a call for a mass meeting for the purpose of discussing the matter of calling an election to vote on the question of a bond issue to raise the necessary money to erect a new high school building, and the Independent falls in line gracefully and says: Woodburn is a city that cannot afford to fall behind in educational facilities." This confirms our suspicion that our neighboring city across the river was away behind Newberg in the matter of school privileges.

## COLLEGE CLIPPINGS

Rev. T. Parker led the weekly Y. M. C. A. meeting the 29th ult. He spoke on the subject of "Prayer."

Last Saturday furnished some excitement when fire was discovered on the roof of the dormitory. Thanks to the timely discovery the flames were soon extinguished and but little damage was done. The fire caught from sparks from a flue burning out, lighting on the roof. It was discovered that the college buildings are without adequate protection in case of serious fire, as the nearest fire hydrant is over two blocks away and the hose of the fire company will not reach from it to the college.

Monday morning at chapel Prof. Hull talked on the folk songs of the American Indians, illustrating his remarks by singing some of the native melodies, two of which he had harmonized for the piano. The accompaniments were designed to express the same feelings as the native instruments.

## PRESIDENT MCKINLEY'S HORSE

Frank, the big black horse which President McKinley prized so highly as an excellent saddler, met a tragic death recently in Strasburg, Ohio, where in green pastures he has been enjoying his latter days. He died of over-exertion in struggling to free himself from a wire fence, to which one of his feet had become entangled.

"Frank was a noble animal," writes the editor of the Strasburg Record. "Where he was born and who cared for him when a colt was not known. He was McKinley's favorite, and during his stay at the national capital, took part in many parades and public military displays. Frank was well known and beloved by all. When the assassin's bullet brought grief to the nation and the noble animal's martyred master was laid at rest in Canton, the horse was entrusted to a relative of Mr. McKinley. About four years ago he was sent to the farm and there he has received the best of attention and care. He was given only such work as old age and distinguished service befit him and those who used him took great pride in keeping him in good shape.

"He was always of the kindest disposition and at times seemed almost human. He had been trained to prance when within the sound of music, and our people well remember what a fine appearance he made in marking time with the band when used in several of our Memorial Day parades. The McKinley horse, as he was commonly known, was twenty-seven years old.

TRAVELING LIBRARIES  
FOR FARMER AND WIFE

The contribution to the general welfare and knowledge in rural communities through establishing simple traveling libraries adapted to the daily needs of the farmer and housewife and distribution of agricultural bulletins, are legitimate parts of the duty of the rural church to the community, according to Bishop Scadding, of the Episcopal church in Oregon.

In a recent address at a convocation of students at the Oregon Agricultural College the Bishop said:

"The church must do, along her lines, what O. A. C. is doing on its experimental farms, like the splendid one I saw last summer in Metolius, raising up agricultural leaders among the people themselves.

"The duty of the church in the country town and the rural community should involve a wider conception of community life than merely a narrow parochial existence; recognition of something distinctive in a country pastorate; alertness like that of secular education; effort toward cordial co-operation with other agencies for the common good, as the country school, the grange, and local improvement societies; leadership and the development of leaders among the people themselves; true service, with ministrations to the sick, the aged, the lonely, and the spreading of good cheer along country highways by rural delivery and the Sunday school; contribution to the general welfare and knowledge through establishing simple traveling libraries adapted to the daily needs of the farmer and housewife and distribution of agricultural bulletins."

BULGARIANS AGAIN  
OPEN HOSTILITIES

Bombardment of Adrianople is Resumed and Other Places are Attacked

London.—The Balkan war has been resumed. The bombardment of Adrianople has recommenced, and a small skirmish occurred at the Tehealja lines. The armistice has lasted exactly two months.

Bulgaria has turned a deaf ear to the remonstrances of the powers, and unless Turkey yields to the Balkan demands, the allied armies will now attempt to drive her completely out of Europe.

Scutaria About to Fall  
According to a dispatch from Belgrade, Scutaria already is on the point of falling. It is reported that the Turkish commander has sent two representatives to the Serbian commander to propose the capitulation of that town.

A report is current among some of the Balkan representatives here that the Porte has already telegraphed to Sofia offering to cede Adrianople on the conditions laid down, and that Bulgaria is ready to accept. This report has not been confirmed at the Bulgarian legation, but it is not considered incredible.

## EDITOR IS IN CONTEMPT

Colonel Nelson of Kansas City Star, Adjudged in Contempt.

Kansas City, Mo.—An appeal to the court of appeals on a habeas corpus writ is the only thing that kept William R. Nelson, owner of the Kansas City Star, multi-millionaire, long a powerful political factor in Missouri and Kansas and staunch supporter of Theodore Roosevelt in the last election, out of jail. Nelson was found guilty of contempt of court and sentenced to one day in jail by Judge J. A. Guthrie of the circuit court, for publishing an article in his newspaper which Judge Guthrie decided was a "sneer at the courts, at the judges and at legal procedure." He also held that it was "contemptuous" and an "open insult."
