



O. A. C. WELFARE SCHOOL COMING NEXT WEEK

Two Days Meeting With Splendid Program Offered.

The Oregon Agricultural College Welfare School, made up of specialists from the Agricultural College, the State Dairy and Food Commission and the Oregon Social Hygiene Society, carrying splendid educational exhibits will be in this city, September 1st and 2nd. The staff has just completed two weeks' work in the cities of the Southern section of the state. Reports indicate that the sessions have been well attended and that the college representatives have left the various cities strongly impressed with the nature of their work. Already numerous requests are pouring in to the extension offices of the college asking for a repetition of the work in the towns visited.

"It is our purpose to take wholesome information to the people of the various communities of the state," said Director R. D. Hetzel of the Extension Division. "We do not pretend to know everything but we do believe that we have something of interest and value to the people of the state if they will cooperate with us and help us to get the information to them."

"We are particularly anxious that every person who is interested in better cities; better social conditions; better health; better morals; better homes and better schools, shall lock arms with us in this attempt to solve our many problems."

The lectures and demonstrations by Mrs. Robbins and Miss Groves, on subjects relating to the home are proving to be of great interest and value to the women of the towns where the work has been offered. These lectures and demonstrations are practical and right to the point. They are of such nature as greatly to help every housewife who is fortunate enough to hear them.

The lectures and demonstrations by State Dairy and Food Commissioner Mickie are designed to bring directly to every community the information that is necessary to preserve the best health of its members. The problems of each community are studied and their advice is given in such way as to bear upon actual conditions. City improvements, including the utilization of vacant lots as applicable here, will be considered by Prof. Peck.

The question of pure foods and pure drinks, which are such a factor in the lives of everyone, are given fullest consideration by Mr. Brodie of the department of Chemistry.

The subject of social hygiene, which is receiving so much emphasis throughout the country at the present time, is dealt with in a masterly way by Mr. Cummins of the Oregon Social Hygiene Society. The staff carries a splendid exhibit from the Social Hygiene Society, the Dairy and Food Commission, the Oregon State Library Commission and the College.

These lectures and demonstrations are free to everyone. The college authorities and others interested in the general welfare in this state and in our home city unite in urging the people of this community to attend these

lectures and view the exhibits.

TEMPERANCE WORKERS MEET IN NEWBERG

County W. C. T. U. Hold Interesting Two Days' Session.

The Yamhill County W. C. T. U. Annual Convention held in the Friends church of this place the 21st and 22nd inst., was a profitable occasion to those attending. The reports show McMinnville to have the largest local organization in the county and Newberg has the second largest. The union at McMinnville was reorganized two years ago with something over twenty members and it now has grown to more than four times that size. Chehalis Center, as in the past, has a very active union.

We have come to expect good things from the Dundee women. They show much attention and ability. Bellevue has forged right to the front for a small union since its organization two years ago. LaFayette has some good, faithful workers. The organization at Dayton is not so lively as a few years ago, but there are some loyal workers who are still "holding on." Sheridan, Carlton and Amity had no representatives in attendance at the convention, but each place has some very capable women in the work.

Mrs. Unruh, the State President, was present the entire first day, giving her help at various times. She was especially helpful in answering the questions contributed to the question box. In the evening she gave a very masterful address making an earnest plea for women to prepare themselves for citizenship and setting forth the advisability of entering a campaign for a dry state in 1914.

Mrs. Elizabeth Meyer who has had the position of office secretary at the State Headquarters in Portland, but who is now residing at Chehalis Center and the new president elect there, read a very helpful paper on "Our Weak Points" and How to Strengthen Them. She also suggested some good literature to be used in the local unions. Mrs. Booker entertained the audience Friday afternoon by giving a most interesting account of her visit to Budapest, Hungary, and various other points en route. The situation and surroundings of Budapest on the Danube bears a striking resemblance to the location of Portland on the Willamette with the exception that the former bears evidence of a much older civilization.

Mrs. Booker's experience in withstanding the warnings that the water in the European cities was not fit to drink and therefore wine or beer was necessary was very interesting. Even in Paris where the water was said to be very dangerous she ran the risk of drinking it and suffered no bad effects whatever. Mrs. Booker had the privilege of attending the World's Sunday School Convention at Zurich, Switzerland, four days.

Miss Minchin who has so faithfully held the office of County President for the past six years, declined a reappointment. Mrs. L. M. Russel, of McMinnville, was appointed to that place. Mrs. Birdie Henry, of McMinnville, is record secretary. Mrs. Elizabeth Johnson, of Newberg, Cor. Secretary, and Mrs. Kulper, of Dayton, treasurer. Though Mrs. Russel is quite new to the work in this county, she gives evidence of having had broad

experience elsewhere and we feel assured she is very competent for the presidency.

As a token of the high esteem and love which the women have for Miss Minchin they presented her a very choice writing desk.

The resolutions adopted by the convention indicate that Yamhill County W. C. T. U. will be ready to fall in line and join a campaign for State Prohibition in 1914.

MORE CIRCUIT COURT NEWS

The Following Cases Have Been Filed Since August 18.

Joseph Matty vs. Dora Lee Smock and others: Suit to quiet title to 44 acres of land near Davis Creek in T. 2, S. R. 5, West. R. L. Conner for plaintiff.

P. A. Flynn and wife against H. M. Kershaw and Andrew Kershaw: Suit for damages in the sum of \$146.00 for withholding possession of a certain piece of land in Willamina. Lange, Hewitt & Nott for plaintiff.

Charles O'Hara vs. Frank C. Bayles: Suit to recover laborers' wages amounting to \$600.00 with attorney fees. B. A. Kliks for plaintiff.

May Crater Beary vs. McMinnville and Yamhill County Hospital Association: Suit to foreclose a mortgage for the sum of \$2950.00 and attorney fees in the sum of \$300.00. B. A. Kliks for plaintiff.

Mike Wirak vs. Hal E. Leedom: Suit to recover \$2067.50, damages for personal injury sustained while working on the Goucher property in McMinnville. Lange, Hewitt & Nott for plaintiff.

Hannah Kelly vs. James F. Sealcup: Foreclosure of a mortgage on Newberg property, \$2500.00 and attorney fee in the sum of \$75.00. B. A. Kliks for plaintiff.

In all, there are 100 cases on the September docket, but the large majority of these cases will be those in which the attorneys will win glorious victories and receive verdicts without even the intervention of a jury. Most of the cases are without opposition. There will be less than ten actual contested cases for the juries to try at this term of court, unless the Grand Jury returns a large number of indictments. Of the total number of cases on the docket filed by Yamhill County attorneys, more than one-half are represented by the two firms of McCain, Vinton & Burdett and B. A. Kliks.
