Let the matter of the sale of cigarettes be put up to the people of Oregon for a vote and the little stinkers will lose their place on the tobacco shelves—and it is coming at the next election.

The Newberg correspondent of the Journal who sent in a report of our recent city election with copious comments thereon, could easily break into the field of yellow journalism without further preparation.

It is a common saying that in any difficult undertaking a whole lot depends on the degree of "stick-to-it" that is displayed by the participants. Conceding that there is much in the assertion, it must be admitted that W. E. Purdy ought to win out in the Winters deed case. He continues to hang on like the traditional dog at a root.

Once each season the smelt very effectively solve the problem of the high cost of living by coming up the Columbia river from salt water in such quantities that they literally fill the Cowlitz and Sandy rivers to the congested stage, and later on become almost a drug on the market. The first of this season's run, which are now showing up in the Newberg markets, are of good size and fine flavor.

At a meeting of the newly elected board of trustees of the fruit grower's association held Wednesday morning, the name "Willamette Valley Grower's Association" was agreed upon for the association. Officers were elected as follows: J. W. Chambers, president and manager; Gottlieb Schaad, vice president; W. H. Woodworth, secretary and treasurer, these to serve temporarily at least. The subscriptions to stock now amount to something more than \$5,000. Every step so far taken seems to have been made with due deliberation, which tends to inspire confidence in the association.

D. N. Byerlee, recently of the Willamina Times, has established a new paper, "The Leader," at Linnton on the west side of the Willamette below Portland. Mr. Byerlee is an old time newspaper man who knows how to do everything about the shop, from sweeping out in the morning to writing luscious obituary notices of "prominent and well known citizens" who never in their lives paid the price of a year's subscription, and Linnton is said to have offered an open field with a good outlook for success for the new venture. Our good friend, Mr. Byerlee, will give the people of Linnton all their patronage will justify, and they can't, with consistency, ask for more.

The June number of the quarterly of the "Oregon Historical Society," just off the press—the Harvey W. Scott, memorial number, is a magazine of more than ordinary interest to anyone who has had an acquaintance with Oregon affairs during the past quarter of a century. Was it an oversight or an intended slight on the part of the Oregonian when our man Purdy was omitted from that list of candidates for governor?

FAULT OF LEGISLATURE

Much discussion is being engaged in by the newspapermen of the state relative to the Copperfield affair, and a number of them who have never been known to utter a word in opposition to the utter disregard of the law on the part of the saloon men, are holding up their hands with horror at the thought of the governor taking the law in his own hands and cleaning up the little outlaw hamlet, Copperfield.

In this connection it is with much pleasure that we have read the following letter to the Oregonian by as good a lawyer and judge as Stephen A. Lowell:

"Without attempting any discussion of either the constitutionality or the wisdom of the declaration of martial law at Copperfield; I am constrained to assert that if the Governor has gone to extremes, the Legislature, and not the executive is at fault. The people demanded of that body at its last session legislation which would assure prompt and complete enforcement of the criminal laws, and the result was the abortive statute of February 25, 1913, which requires a tedious, and probably, in most cases, useless court proceeding to remove officers who are neglectful of duty. Under the rules of evidence which govern courts it is not easy to prove facts which on general principles every reasonable man knows to be true. The state asked bread, and was given a stone.

"Had the Legislature responded to public sentiment, and enacted a statute which would permit the Governor to temporarily suspend public officials, and appoint special officers in their places, when in his judgment occasion required, there would have been no occasion for the declaration of martial law either in Baker County, or elsewhere. Under such a statute law-breakers and their sympathizers might suffer. Certainly law-abiding citizens and law-enforcing officials would not be injured.

"There is little doubt but that the great majority of the people sustain the Governor in his law enforcement crusades, and properly so, in my judgment. They may have some lurking doubt as to whether martial law was originally intended for such conditions, but it seems the only efficient weapon available, and until the Legislature places some prompt and effective civil remedy in the executive hands, he will be applauded for declaring the rule of war. The constitution commands him to see that the laws are faithfully executed and enforced. If he cannot do that with pens, he is justified in doing it with bullets. The law must be supreme.

"If law enforcement is to be the issue in the coming campaign, I hope that Oswald West will become a candidate to succeed himself. On the issue thus raised I apprehend that party lines would vanish, and that he would be triumphantly elected."

GOOD REPORT COMES FROM CORVALLIS

Benton County Grower's Association Makes Satisfactory Showing For the Year.

S. L. Parrett, president of the U. S. National Bank, recently wrote to the First National Bank of Corvallis asking for information regarding the success of the Benton County Grower's Association, and a letter was forwarded to him written by George H. Tinker, secretary and manager of the association, from which the Graphic has been permitted to make extracts.

Mr. Tinker says the business of the association has not been closed up for the year and consequently he is unable to report in full, but that they are sending out checks to growers for various commodities figured on the following basis:

No. 1 Loganberries, \$70 per ton; No. 1 strawberries, \$60 per ton; cherries, \$70 per ton; canning apples, \$11 per ton; cabbage, \$10 per ton; green beans, \$30 per ton; rhubarb, \$15 per ton; No. 1 Bartlett pears, \$30 per ton; No. 2 Bartlett pears, \$25 per ton; No. 3 Bartlett pears, \$20 per ton; Pie plums, \$10 per ton; No. 1 Italian prunes canned, \$20 per ton; raspberries, \$80 per ton.

"For fresh fruit shipments in carload lots, we have realized splendid results, considering the quality of the apples.

"We have been bringing into the county for apples shipped in carload lots from \$660 to \$720 per car as against as low as \$35 per car before we were organized. Before we were organized we paid 15 to 20 per cent as commission to have our apples given away, while under present marketing methods, it costs only about 4 per cent to do our own business on a good profitable basis in fresh fruits and vegetables.

"We have put into cans this year something like a million pounds of fruit and vegetables that could hardly have been marketed at all without the present facilities for putting it into marketable shape.

"The gross business done during the past season is approximately \$50,000.

"We can now safely say that we have an established business, in so far as our ability to put up a first class article of goods is concerned. When you consider that the institution is less than two years old, we believe we are justified when we say we have been successful. When we started out to do business, the wholesale concerns were very backward about taking hold of any of our goods, but the contrary is now the case. We could have sold at least one hundred car loads more of our products this year if we had been able to furnish the goods."

OBITUARY

Matilda Irene Meigs was born near Springfield, Illinois, March 3, 1858. Here she grew to womanhood and in the fall of 1880 followed her widowed mother to Southern Nebraska.

In Hastings, Nebraska, on September 5, 1883, she was united in marriage to Davis Pindle Strait. Then came busy, happy days as she joined her husband in subduing and making into a beautiful home a plot of virgin prairie near Fairfield, Nebraska. Here were born three children, Ferris L. and Sylvan D. both now of Newberg, and Belya E., now Mrs. F. L. Hill, of Orchard, Wash. In the autumn of 1902 she with her husband and family removed to Oregon, settling near Newberg in February, 1903.

Last Spring she became a sufferer from arteriosclerosis and after weeks of patient suffering passed away on January 7, 1914.
