YOUTHS CONFESS TO MANY ROBBERIES.

Some time in May two young men who said they were from Portland called at the Graphic office, one of them asking for a place as an apprentice printer, saying he was from a good family and could furnish good references. They staid over night in the Gregory Apartments and after they were gone some of the roomers complained that their rooms had been entered and numerous articles stolen.

The following news note from the Journal tells of the final rounding up of the youngsters: Following their arrest by City Detectives Coleman and Snow, John Churchill, 20, and Lentz Mummy, 19, residing in Lents, made confession of a long string of robberies. A report was made to the police department yesterday that two boys were peddling postage stamps to houses in the Ladd tract, and the detectives went after them. They were arrested at noon.

They soon admitted robbing the house of R. L. Morris, 661 Locust street, June 2, stealing a violin, revolver, jewelry and \$3 worth of postage stamps. These were the ones they were selling, the officers say. They also said they had robbed the Dayton hotel May 26, stealing half a dozen rifles and shot guns. Before that they said, they had robbed the home of a Mr. McCoy at Newberg, with his strong box, holding deeds and papers.

Finding nothing of value in it, they said they hid the box under a sidewalk, and then stole a rowboat to come to Portland. The owner went after them in a launch, however, and took the boat away from them. Then they stole a motorboat, in which they came to Oregon City, where they abandoned it.

FINE OF \$250 AND 90 DAYS IN JAIL.

"Pretty hard for a first offence," was the comment of a man on the street over the sentence by Recorder Loder of \$250 fine and 90 days in jail for the bootlegger.

Not bit too hard. That man knew Oregon City had gone dry and that it was a crime to sell liquor here.

Yet he came here and took the chances, and he got them—good and plenty, and just what he should have gotten.

This system of letting a man off light for the first time he openly breaks the liquor laws is simply encouragement to break them again.

We have seen saloonkeepers in this city confess to breaking the law get a fine of \$25 and be arrested again in less than two weeks.

We voted booze out of the city. Sentences like Mr. Loder handed to the bootlegger will keep it out—it will have a mighty restraining influence on the next man who is considering it.

Mr. Loder has the sand to do just what the majority of the people want him to do, and just what it is his duty to do.—Ore. City Courier.

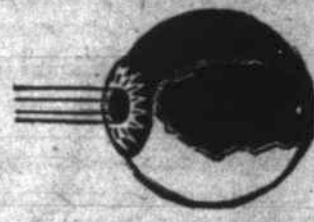
Annual School Meeting.
