## OREGON DRY PARADE

Sunday Schools Out Sunday  
Afternoon to Swat The  
Rum Demon.

On last Sunday afternoon the first out-door demonstration in favor of putting the state of Oregon in the dry column was made by the people of Newberg, when the various Sunday schools paraded the streets, carrying banners, and a public meeting was held at the city park where the demon rum was given many severe thrusts.

The line was formed at the corner of First and Washington streets and headed by Bert Miller and Wm. Brooks, as drummers, the procession marched down First to College, up College to Fourth and west on Fourth to the park where the exercises were held. The number in the parade was above five hundred.

The exercises were held under the direction of Mrs. L. A. Moore, president of the W. C. T. U. and Kienle's orchestra furnished excellent music for the occasion.

Readings were given by Miss Bullard, Miss Bessie King and Mrs. Cora Diedericks, short talks were given by Bert Miller and Teddy Leavitt and there were various exercises by the little folks.

At night a large crowd gathered at the park and was entertained by Jack Frost, the temperance evangelist from McMinnville, who showed a series of stereopticon views illustrating the story, "Ten Nights in a Bar Room," accompanied with a forceful running sketch of the book given with a strong voice that could be heard by everybody. A number of very good pictures of mountain scenery and various places of interest were also thrown on the canvass. Mr. Frost announced at the close of his talk that he was ready to go to school houses and out-of-the-way places to give his illustrated lecture wherever calls were made.

## EGGS BY PARCEL POST TO CONSUMERS IN CITY

Eggs properly packed in suitable containers can be shipped in quantities of ten dozen for a distance of 50 to 150 miles and the containers returned at a total cost of slightly more than three cents per dozen. The rates for smaller shipments is slightly higher, those for larger some lower, but the difference is not very great. In any case, the cost of shipping the eggs and returning the container is less than the charges of the buyer, commission man and the retailer, as made in the usual channels of marketing eggs. By taking advantage of this situation producers should get a little better price for their eggs, consumers should get their good eggs, at rather less cost, and consumers' families should get a regular supply of good eggs.

For his extra profit on his eggs the farmer gathers them regularly each day, twice a day in warm weather, stores them in cool, clean places and ships them promptly. The experimental shipments by O. A. C. were made in a container that has ten paper rolls inside, each roll holding a dozen eggs in a perforated lining. Its weight is about 4 pounds. When filled with good eggs of good size the combined weight of case, containers and eggs, is about 20 pounds.

The cost of sending 20 pounds a distance of 50 to 150 miles by parcel post is 24 cents. The rate for returning the 4-pound container is 8 cents. Thus the entire cost of the shipment of ten dozen eggs not counting cost of container is 32 cents, which is slightly more than 3 cents per dozen.

## BIG DEBATE NEXT SUNDAY

E. church with headquarters in Topeka, Kansas, while the "wets" will be upheld by Col. E. Hofer, formerly editor of the Capital Journal, of Salem, but now the editor of the Oregon Manufacturer.

Both these men are strong speakers and there will be fireworks sufficient to keep everybody awake every minute of the time the platform is occupied.

## CARLTON SAW MILL BURNS

On Wednesday night the plant of the Carlton Lumber Company, owned by Charles E. Ladd, of Portland, was destroyed by fire, entailing a loss of \$500,000.

Help was sent from Yamhill and McMinnville, and the planing mill and ten million feet of lumber were saved. There was no wind blowing, else the loss would doubtless have been much greater. Insurance to the amount of \$250,000 was carried on the plant.

## DEATH OF A PIONEER

Benjamin Heater Passes Away  
At Ripe Age of 93.

Benjamin Heater was born, February 10, 1821, in Brackston County, West Virginia. He moved with his parents to Henry County, Iowa, in 1837.

On February 18, 1847, he married Mary J. Shuck, and in the spring of 1850, they started with an ox team for Oregon. They were six months crossing the plains, arrived in Yamhill county in the fall of 1850, and located on a donation land claim, where they have continuously resided until the time of his death, excepting for a period of ten years, which they spent on the Smith place in West Chehalum.

He is survived by his wife, Mary J. Heater, four daughters, namely, Mrs. Lizzie Winters, of Springbrook; Mrs. Mary Judy, of Amity; Mrs. Susan Coutts, of Spokane, Washington; Mrs. Lucinda Putman, of Springbrook; four sons, namely, Charles M. Heater, of Pullman, Washington; Albert, Ernest and Grant Heater, of Springbrook. He was the father of twelve children. He also has twenty-three grandchildren and nine great grandchildren.

He died August 9th and was buried on Chehalum Mountain near his home, the Rev. Geo. C. Ritchey of the Christian church officiating at the funeral services.

## FOUNDER OF THE GRAPHIC DIES IN CALIFORNIA

John C. Hiatt who founded the Graphic in December, 1888, died August 2 at Rivera, California, at the age of 74 years.

Mr. Hiatt was one of the first settlers of Whittier and when that city began to pick up during the boom times in Southern California established the first newspaper of the place which was named the Whittier Graphic. The paper started out well but with the depression that came in that section a few months later he was forced to suspend publication and the little plant was moved to Newberg and the Newberg Graphic established. His son, Wm. Hiatt, now an attorney of Los Angeles, was in charge of the paper.

Mr. Hiatt was an Indian by birth, but spent the greater part of his life, before locating in California, in Iowa. He was a veteran of the Civil War and was a prisoner both in Andersonville and Liby prisons.

Improvements Made and How It is Being Appreciated.
