Old King Alcohol is getting some jabs in the slats these days that are puncturing his tough old hide and making him wince, and there are more and harder ones coming.

With the rivers of Oregon working overtime these days, and with reckless auto drivers doing their bit, the undertakers and grave-diggers are being kept fairly busy.

Man's attire for a woman may be permissible under some special conditions, but—well, as a fad out on the public thoroughfares, let it be the other fellow's wife or daughters.

The crop of evergreen blackberries growing wild promises to be good, and with the Valley Canning Co. wanting all that can be secured, here is an opportunity for boys and girls to make pocket money. Not a berry should be allowed to go to waste this season.

The dean of the division of home economics in Kansas State Agricultural College is publishing an appeal to the people through the medium of the Kansas newspapers under the head, "Eat Corn Meal—It Is Cheap and Nutritious," which sounds well, but since a letter was received here a few days ago from Kansas saying corn was selling there at \$2.05 a bushel, we can't understand how the dean is able to figure corn-meal as a cheap diet.

These days it keeps the big dailies guessing, all the same as the small country newspapers, when paper bills are to be paid. It is said that the New York Times is required to pay \$750,000 more for its white paper this year than it paid last year, and that the Chicago News is paying nearly a million dollars more for its paper this year than last. It was brought out in a law suit recently that the morning Tribune and Evening Express, published by Edwin T. Earl of Los Angeles suffered a loss last year of \$275,000.

Portland is liberal in allowing lawn-sprinkling every day and in addition allows the free use of water for gardens, and still has plenty of water, says the Oregonian. So does Newberg have an abundance of water but so much of it is being allowed to go to waste from the lack of a few hundred feet of pipe connection, that we are cut down to an hour each evening for sprinkling, which is mighty poor service to say the least. And Newberg will not stand for it another season if the Graphic can arouse enough interest among the people to see that the wrong is righted.

GOVERNOR WITHYCOMBE SETS BAD PRECEDENT

Oregon City, Aug. 7.—Larry M. Sullivan, former proprietor of the Friar's club, who was convicted with Martin Denny for bootlegging, was pardoned by Governor Withycombe yesterday. In a letter to District Attorney Gilbert L. Hedges, who prosecuted the case, Governor Withycombe says he granted the pardon because he believes Sullivan has suffered enough and because of the disgrace suffered by Sullivan's family. Pressure was brought to bear on Mr. Hedges, he said today, to recommend a pardon for Sullivan, but this he refused to do, saying that he believed the only way to stamp out persistent bootlegging is to put the bootleggers behind the bars. Mr. Hedges went to Salem today to attend a meeting of district attorneys, and will call on Governor Withycombe to discuss the matter. Sullivan was under sentence of 30

days and \$250 fine and costs, and was at liberty pending a decision of the supreme court. His appeal was denied recently and he would have commenced serving his sentence as soon as the mandate was returned here. He is to pay \$100 at once and \$50 a month until he has paid his fine.

The above bit of news appeared in the Evening Telegram on Tuesday, and in commenting on the action of the governor the Graphic is free to say that we think he has erred in overriding the opinion of District Attorney Hedges and granting a pardon to this man Sullivan.

When the people voted the saloons out of the state the governor issued an edict to the various officers of the law to the effect that they must put the lid on tight and go after the bootleggers with vim and vigor, enforcing the law without fear or favor shown. Apparently the most of them took him at his word for the new dry law has been enforced throughout the state much more satisfactorily than had been expected by the most enthusiastic supporters of the dry law.

The booze dispensers have given the officers a lot of trouble in Clackamas county for a long time and when the district attorney succeeded in landing the proprietor of the notorious Friar's Club there was general rejoicing, for it was hoped that it would mean the breaking up of a bad nest. Now with the news coming that the governor has stepped in and granted a pardon there will be much disappointment. Here is the reason given for granting the pardon. "Governor Withycombe says he granted the pardon because he believes Sullivan has suffered enough and because of the disgrace suffered by Sullivan's family."

Had it been a young, inexperienced man who went wrong, this being his first offense, it would have been different. But with an old offender who was trying to beat the law—that is a different story.

Mr. Hedges is right when he says the only way to stamp out bootlegging is to put the bootleggers behind the bars, and we commend him for his grit in refusing to yield to pressure brought to induce him to recommend a pardon in this case.

It is mighty poor encouragement to a district attorney to prosecute such offenders when he is virtually turned down by the governor after he has succeeded at the end of a long fight in landing such a one as Sullivan.

If the people are satisfied with the action of the governor in this case let it go at that, but if they are not, they will do well to let him know what they think about it. The position of the Graphic will doubtless be understood.

A TRUE Y. M. C. A. ARMY STORY

Rev. George Adam, a minister of Great Britain, speaking before the thirty-ninth international convention of the Young Men's Christian Association, in Cleveland, Ohio, recently, used the following true story to illustrate the problem that is before the National War Work Council of the Y. M. C. A. in the war zone where it is seeking to intrench the association in the hearts of the soldiers as a moral power. "One day at one of the camps," said Rev. M. Adam, "an association man was sitting at a counter selling stamps. The boys were writing their letters home and this man noticed two boys writing a letter, and this letter was apparently causing a great deal of fun, and so he said to the boy when he came up for his two cent stamp, 'I hope you have written a nice letter to that little girl back there in Canada. Those girls deserve it, you know.' As the soldier turned away the blood ran up his neck and reddened his ears. He tore that letter to bits and dropped it into the stove and the flames were turning that paper into gray ashes when he came over to the counter and said, 'Thank you, sir, good

night.' But the soldier was not to get off so easily. The man went after him and said, 'Jack why did you tear that letter?' 'Oh, sir, don't ask me. I have torn it.' 'Jack, why have you torn it?' 'Well, that man that was helping me write that letter has been on his leave, and he gave me the address of the woman with whom he spent his time, and I was making an appointment for my leave next week. But, sir, I am not going; I have burned that letter. God help me, I will remain true to my little girl in Canada.'

MUM-SOW, AGED INDIAN SQUAW DEAD

Mum-sow, aged Indian squaw who was the widow of Five Crows, one of the warriors who abruptly brought an end to the Bannock war of 1878 by the capture of Chief Egan, died last night at her home on the Umatilla reservation. Her husband, whose name has been written into history, died a good many years ago. Five Crows was one of the party of several Indians who went with chief Umapine to the Bannock war chief's camp and, under pretense of joining him, enticed him away and took him prisoner. When he attempted to escape while being brought to the United States soldiers at the Umatilla agency, he was killed, and Five Crows is generally credited with being his slayer. His head was cut off and presented to the white commander.—East Oregonian.

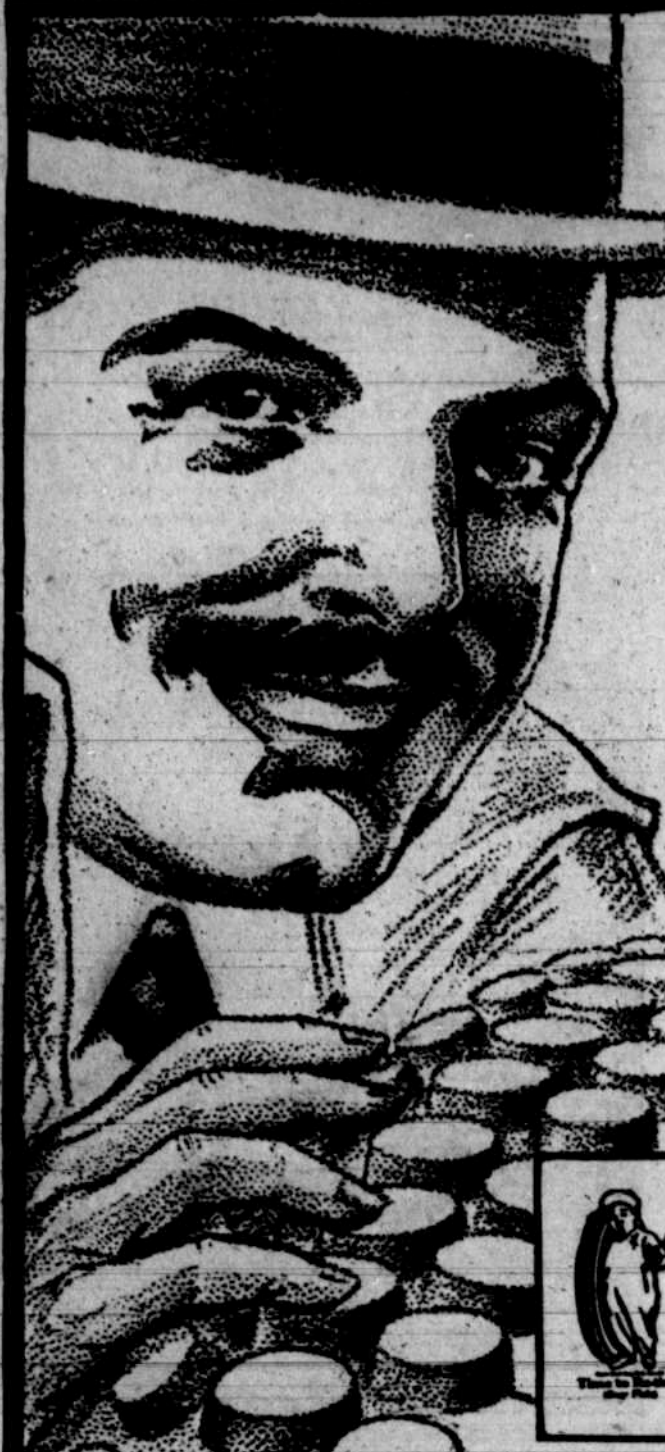
