Of the many annual gatherings of Oregon newspaper men which the editor of the Graphic has attended in the twenty-seven years of newspaper experience he has had here, he can only recall two or three meetings that the Headlight man has attended.

An appeal is being made for books to supply reading matter for the thousands of young men who are assembled in the military camps in the neighborhood of Portland, and Miss Langton, our librarian, has taken the matter up with the hope that a hearty response may be made on the part of our people. She knows something of the taste of young men and she suggests books by Kipling, Doyle, Stockton, Bindloss, Tarkington, Oppenheim, Hopkinson and Kister, but any good novels, stories of adventure, history, biography and travel will be appropriate. Books, however, must be readable to be of any value and old, uninteresting works are not wanted. Miss Langton will gladly receive and forward any books of the nature mentioned that may be offered and she hopes that the appeal may bring results.

The Graphic continues to receive literature in opposition to national prohibition sent out from the booze headquarters located in the old whiskey and beer soaked city of Cincinnati. In the last batch to come there were clippings from the Louisville Courier-Journal, Marse Henry's paper, and of course it makes interesting reading, coming as it does from the great blue grass country, famous for its mint juleps. In discussing the vote of the Senate on the Sheppard resolution for a prohibition amendment to the constitution the Journal says:

"In this aspect of their action there is no patience now to analyze the factors of this disgusting proceeding—the bald sophisms by which men who knew

better attempted to excuse their conduct, the transparent trickery of the selfish politicians; the pitiable cowardice of the invertebrates; the whining pharisaism of the adle-pated fanatics; the morality-maudlinism of the perennial Pecksniffs; the freebooter's ethics of the pious pinheads, who would ram the love of God—their God—into men's hearts under penalty of law."

Under the head "A Son-of-a-Gun From Bitter Creek" the Journal says:

"To a man of Senator Morris Sheppard's stunted intellectual growth and limited mental vision the yawp of the temperance lecturer, like the cackle of the little barnyard hamlet where he lives when at home, seems the noise of all the world. Men of his caliber learn nothing. But men of his environment—the two-State wilds of Texarkana, where a gentleman who gets drunk in Arkansas may sober up in Texas, and vice versa, escaping the Sheriff of each vicinage the while—could profit by nothing he might read in the doubtful event that he ever read at all. Such a person in the Senate of the United States recalls nothing we can think of except, Mrs. Poyser's cock that thought the sun rose just to hear him crow. Obviously Mr. Sheppard is the original son-of-a-gun from Bitter Creek, high-up and north side!"

## LET THE GOVERNOR KEEP HIS HANDS OFF

Editor Graphic:

I wish to thank you for a copy of the "Newberg Graphic" received this morning, and which contains an editorial in reference to the pardon of Larry Sullivan by the Governor of this state. I wish to commend that editorial to the perusal of others, and to repeat, as I have often asserted, that there is but one cure for persistent boot-leggers in the State of Oregon, and that is a season behind the bars.

I have often, in my experience, found that the mere imposition of a fine invites subsequent infractions and amounts in the end to a mere license of such places. The penalty under the law is adequate, and if we are not interfered with we can enforce this law to the letter anywhere in the state, but executive clemency given to a man after he has been condemned to jail by the courts weakens the purpose of the prohibition law and sets a precedent which invites others to break the law.

Were I governor of this state, I am quite well satisfied that boot-leggers would become thoroughly familiar with the inside of our jails.

## COLD TEA

No one will sympathize with the illicit buyer of whiskey who uncorks his bottle in thirsty anticipation, only to find that it is filled with cold tea. For one thing, this subterfuge of bootleggers is almost as old as the hills, says the Oregonian. It no more ought to fool a reader of the day's news than the ancient gold brick or sick engineer swindle. The operation of the scheme has been standardized. It is always the same. The purveyor offers the customer a bottle of "tea" and winks, knowingly. The deal is made and the party of the second part some time thereafter is highly indignant because he got precisely what he contracted for.

The buyer, of course, knew in the beginning that he was making himself party to a violation of the law. If he had been law-abiding, he would not have been cheated. It is so with most confidence games. The fellow who puts up his money for a supposed bunch of "green goods," guaranteed to defy detection, thinks he is going to make some "easy money." At heart he is as much a lawbreaker as the man who swindled him. He sometimes pays a high price for experience, but it is worth the price if it teaches him that lawbreaking, from any angle, seldom pays in the end.

Anyway, it is better to drink tea than booze—particularly bootleg booze. Tea is the classical cup that cheers but does not inebriate. But there is no necessity for paying bootleg prices for it.
