A. S. Mellenger and L. Reed Chambers, large growers of loganberries, have sold their respective crops to the Puyallup & Sumner Growers' Association.

Chris Smith, who had been working at Astoria, and Ellis Pickett, who had been teaching in a high school in California, returned here the latter part of last week to answer the draft call at McMinnville on Tuesday of this week. The former was a member of the graduating class of 1912, Pacific College, and the latter of the class of 1915.

James Patterson was settling up his affairs about town the first of the week preparatory to leaving for his ranch at Blaine, Tillamook county, to be in readiness to begin his contract carrying mail between Blaine and Beaver the first of July. His tea and coffee stock he turned back to the company in Portland and the balance he sold to the Miller Mercantile Co.

George L. Kelty, who made a trip into Polk county the first of the week soliciting cream for the Newberg creamery, going as far south as Holmes Gap, says he saw many women and old men who have passed the "farm draft" age, helping in hay harvest. Exchange of work between farmers, he says, is also much in vogue again, owing to the absence of young men for farm help. The clover hay crop he found to be good and the wheat looking much better than it does down this way.

F. S. Fish, of Philomath, has contracted with F. Groshen, of West Chehalis, for putting in a small saw mill on the latter's farm and has the mill on the way. He will use a traction threshing engine and expects to get out about 8,000 feet per day, mostly railroad ties, using four men. The mill will be set up on a small stream back of the Groshen farm house, which was built several years ago by the late L. W. Harger, deceased. Mr. Groshen has contracted with a Milwaukee man named Cornwall to cut and deliver the logs at the mill.

Lynn B. Ferguson, the local druggist, told an interesting story the other day of how he became a special recruiting agent for the United States Shipping Board. At a convention of Rexall druggists in Boston, Louis K. Liggett, president of the United Drug Company, made a strong address, in which he stated that the U. S. Shipping Board had accepted an offer from him on behalf of 6,854 druggists, all over the United States, to aid the board in its vital work of securing qualified recruits to train for crews in the new Merchant Marine. These druggists were the stockholders of the United Drug Company, Mr. Ferguson being one. Mr. Liggett put the plan of serving the Shipping Board as special recruiting agents at \$1 a year up to the druggists on patriotic grounds, pointing out that in this way they could be of actual help in winning the war. Mr. Ferguson was one of the first to accept an appointment. Several hundred of the druggists stood up at the close of Mr. Liggett's address, in the Boston convention, and took the solemn oath of office. The United Drug Company has 8,000 stockholders who own 6,854 stores in 6,393 cities and towns of the United States. Mr. Liggett has been informed officially that if each store sends one man a month to the training service of the Shipping Board, the enlistments thus secured will be sufficient to meet all the demands of the Merchant Marine for its new all-American crews. The men accepted for the Merchant Marine are exempted from the draft.

Courtney Douglas, a young man from Worcester, Ohio, is here to spend the summer with his uncle, W. W. Silver.

Miss Emma Silver, who is home from Shanghai, China, where she spent twenty-three years in the mission field, is in town visiting her brother, W. W. Silver.

Seventeen girls under the care of Mrs. Keller came out from Portland Monday and were taken to the A. S. Mellenger loganberry farm on the river to be put at berry picking.

A. Burr Black, special field agent for O. A. C., is in this section looking up fruit pest insects and he advises growers to get cherries picked as early as possible, owing to the fact that a fly is being hatched in the fields that may give trouble.

George W. Morgan, who came here some time ago from Chicago, says there is at least one honest man in Newberg, namely, E. C. Arnett, of the City Transfer Co. On Monday Mr. Morgan lost his coat on the road out north of town and in one of the pockets there was a book containing \$200 in Liberty Bonds, a \$2,000 draft and other valuable papers, all of which were restored to the owner.

Thirty-six boys are here from Portland in charge of R. E. Fennor for cherry and berry picking. They are members of the "Working Boys Reserve" and are sent out under the direction of the Y. M. C. A. Their camp is in the grove near the cannery and they are sent out to help growers who are patrons of the Valley Canning Co. They are a jolly, husky looking bunch and will no doubt help materially in supplying needed labor at this time.

At about 8:30 o'clock on Monday morning I. C. Morris, fireman at the Jones Bros. juice plant, dropped dead in the engine room while in the act of putting a stick of wood in the furnace. Deceased lived on Dayton Avenue and besides his father, Joseph Morris, aged 88 years, he left a wife and eleven children, all of whom are living. He was one of a family of nine children and all the others are living. His age was 64 years. Funeral services were conducted at the W. W. Hollingsworth Co. chapel on Wednesday by Rev. B. L. Hicks.

At 2:30 o'clock on last Friday morning the night watchman at the saw mill discovered a small blaze that was getting under way on the floor of the wagon bridge that spans the Willamette a short distance below the mill. He telephoned the alarm at once and the fire bell called out the fire fighters, who hurried to the scene, a mile away, and soon had the fire out. Little damage was done, but it was fortunate that the fire was discovered in its incipency, for with a little more time for a start it might have developed into a bad one. It is supposed that the fire originated from the stub of a cigarette that was tossed aside by a smoker.

He has leased the building on North Main street formerly used as a sash and door factory, where loganberries will be received by A. E. Lovejoy, representing the association. They will be put up in barrels for shipment. Mr. Greisen, who was formerly associated with Mr. Shepard in the publication of "Better Fruit" at Hood River, was born in Denmark and in conversation relative to the probable outcome of the war he is both interesting and instructive, showing as he does a keen insight and wide range of knowledge of conditions over there. He says he does not look for a knock out blow on the part of either side, and thinks concessions will have to be made by both sides before the end is reached.
