Sheldon A. Stubbs, who has been located at Pendleton since leaving Newberg, has recently been elected captain of a squad of state police. Mr. Stubbs made several attempts to get into army service while he was living here but was turned down each time.

The reason is that the scarcity of labor compels them to buy drills and gang plows and tractors to enable one man to do the work of several. In some parts of the county the young women make full farm hands. He is again listed in the column of wounded and this time put down as being seriously hurt. He is only eighteen years of age.

Arthur W. Stockman, of Springbrook, who was wounded while in action in France, in writing to the home folks on September 22 says: I received your last letter at the Base Hospital. Since then I have been transferred to the Convalescent Hospital. It is a small place by the beach. The hotel is used for a hospital with three or four men to a room. Nothing to do but eat, sleep and exercise and go up and down on the beach. There are a lot of people in bathing every day. Quite a number come here from Paris to spend the summer, but are leaving again at this time of the year. Today is Sunday, and it rained for a little while. I am getting along fine now, my wound being almost healed, but have no feeling in my leg when I walk. Have lost everything I had. We were surprised when we came down here and they told us this would be our home. Sitting at a table with real dishes and sleeping in iron beds, with white sheets makes us feel pretty good. Send clipping from newspapers and let me know your side of the war.

OBITUARY OF ELIZABETH BRYANT POWELL

On Thursday morning, Oct. 31, at 1:15 o'clock "grandma" Powell, beloved by everyone in the community, passed into her last sleep at the home of her son, H. B. Powell.

Though practically a shut-in for the past few years Mrs. Powell has taken a keen interest in all the activities of the community and she busied herself with handwork up to within a few weeks of her death. For the last few weeks she has been knitting wash cloths for the boys from Yamhill County who have answered their country's call.

Mrs. Powell was a woman of unusual sweetness of disposition, a gentlewoman, whose kindness, courage, and cheerfulness has been a benediction to all her neighbors and friends. She was a member of the Christian Church and lived the life of a true follower of the Master.

Elizabeth Bryant was born in June 1838. In May 1854 she married J. P. Powell. They came to Oregon in 1876, living the first two years in Marion County and the rest of the time at McMinnville and Dundee.

Mrs. Powell was an artist of considerable ability. She studied work in oils for years in Cincinnati, Ohio, and taught oil painting for a long time after coming west. Her work with the brush was abandoned only a few years ago when failing strength made it too arduous. Her portrait of her father is a painting of unusual merit and places her work high in that branch of art.

Mrs. Powell is survived by her husband, Prof. J. P. Powell, a daughter, Mrs. Minnie E. Turner, of McMinnville, two sons, Estle C. Powell, of St. Johns, and H. B. Powell, of Dundee; several grandchildren and some great grandchildren.

The funeral services were private, from her son's residence, and interment was in the Dundee cemetery.

The sympathy of the community is given to the bereaved family and especially to Mr. Powell whose tenderness and devotion to his wife have been a beautiful lesson to us all. They were devoted lovers to the last and the harmony of their home has been a blessing to all who have been privileged to know it.

COMMUNITY HOUSES INSTEAD OF MONUMENTS

The erecting of community houses as fitting memorials to the brave men, living and dead, who are saving the world for Democracy, is suggested editorially in the American City. "Liberty Buildings" is the name proposed for these new structures, which, erected immediately after the war, would perpetuate the democracy of the camp and would serve as neighborhood gathering places for civic activities and fellowship for all the people.

It has been pointed out that there are some fifteen hundred thousand new men now in training for military and naval service in the United States, and approximately as many more in the American forces overseas.

No mere shaft of marble or granite can ever symbolize the Democracy for which this world war is being fought.

Because Many of them will need succor and encouragement because they are permanently crippled.

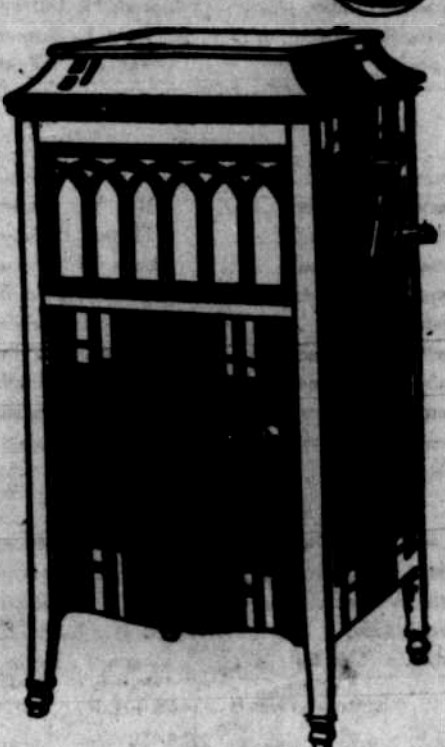
Because They gave their all, we cannot afford to be niggardly. Because This may be our last chance to do our bit this way.
