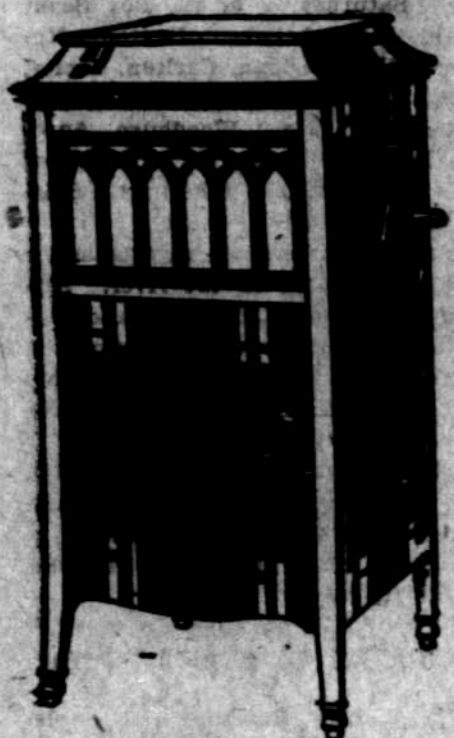

MARTHA J. VESTAL, DECEASED

Martha Jane Lightfoot, daughter of Isaac and Emma Jane Lightfoot, was born near Barnesville, Ohio, May 25, 1838. At the age of 15 years she went to Plainfield, Indiana, to live with an uncle and aunt, where she remained until the time of her marriage, September 6, 1865, to James M. Vestal, of Plainfield. In a few months they moved to Johnson county, Kansas, which was their home for 24 years.

To this union four children were born, namely, P. E. Vestal, of Pasadena, California; Emma Ehret, of Newberg, Oregon; F. E. Vestal, of Suffolk, Montana, and W. J. Vestal, of Salem, Oregon.

They moved with their family to Newberg April 21, 1889, which has since been their home. The deceased was converted while young and lived a devoted, trusting Christian the remainder of her life, being in full sympathy with the revival spirit and evangelical work of the church. Her living testimonies to her religious experiences and unwavering faith in the Lord Jesus Christ were encouraging to both old and young.

A large circle of friends and relatives mourn the loss of our dear mother in Israel. We believe her work was done, and that she is gathered home as a sheaf of corn fully ripe in the heavenly garner.

On the first day of May she fell and sustained a fracture of the hip which confined her to her bed for two weeks, when she peacefully passed away, at the age of 80 years, 11 months and 15 days, at the home of her daughter, Mrs. Henry Ehret, with whom she had made her home for the past six years.

James M. Vestal, the husband of the deceased, died here in 1906.
