DEATH OF YAMHILL COUNTY PIONEER

Judge William Galloway, Oregon pioneer and one of the best known jurists in the state, died Tuesday at The Dalles. Judge Galloway was visiting his son, District Attorney Francis V. Galloway, of Wasco county. The judge was 68 years old.

In 1852 William Galloway came across the plains with his father and mother, with an ox-team from Wisconsin. Galloway senior established a farm in Yamhill county. At the age of 19 the lad entered Willamette University. Six years after graduating he married Miss Emma Baker, of Yamhill county.

Judge Galloway entered upon his political career in 1876, when he was elected to the lower branch of the state legislature. After serving three consecutive terms, he was elected judge of Yamhill county. In 1894 he ran for the office of governor on the Democratic ticket, but was defeated by William P. Lord, Republican. Two years later he was appointed receiver of the land office at Oregon City, which position he held until 1903.

The following year Galloway was elected to the judgeship of the old third judicial district, and in 1910 was re-elected. At the conclusion of this term he retired.

Surviving Judge Galloway are three children, Charles V. and Miss Zilpha V. Galloway, of Portland, and Francis V. Galloway, of The Dalles.

INTERCHURCH MOVEMENT PLANS MEDICAL AID FOR CHINA

In no part of China is there a medical force at all adequate to the needs of the situation. In one province there is but one doctor to five millions of people, and missionaries living in lonely stations must travel many days to procure medical help in case of need. The program of the Interchurch World Movement, based on a careful survey, will include the strengthening of present institutions and the opening of a large number of hospitals in new areas where they are most needed.

Coral Fisheries.

In consideration of its slow growth the coral reefs are fished once only in ten years. The fishing boats engaged in this extremely lucrative business varying in size from three to fourteen tons. The most valuable fisheries are among the coral reefs of Tunisia, Algeria, and Morocco, the raw material going chiefly to Italy. The red coral of the Mediterranean and the Red sea is exported in large quantities to India for the manufacture of ornaments and articles of personal adornment. The black coral of the Persian gulf and Great Barrier reef is still more highly prized.
