Oregon Man Leader in Great Religious Program



WILLIAM HIRAM FOULKES.

On the "general staff" of perhaps the greatest alliance of American Protestant Churches in history—the Interchurch World Movement—is a former pastor of Presbyterian Churches in the Middle and Far West: William Hiram Foulkes of New York City.

Vice chairman of the Interchurch executive committee and associate general secretary in its cabinet, Mr. Foulkes still finds time to direct the \$46,000,000 New Era Movement of the Presbyterian Church, which is that denomination's part in the interchurch program for Protestant cooperation in world-wide missionary advance.

Born in Quincy, Mich., Mr. Foulkes preached in Elmira, Ill., Clinton, Mo., and Portland, Ore., before he came out of the West to become pastor of Rutgers Church, New York City. His nation-wide campaign for aged clergymen, as general secretary for ministerial relief and sustentation of the Presbyterian Church, made known his ability as an orator. In 1910 he was sent to Edinburgh as a delegate to the World's Missionary Conference. He is secretary of the executive committee of the Presbyterian National Service Commission.

BEWARE OF FAKE MAGAZINE PEDDLERS

Recently there has appeared in the western states a team of discharged soldiers who, after fighting in the recent war to uphold the dignity and principles of our flag and the United States uniform, insist upon belittling and desecrating the uniform by wearing it to arouse the sympathy of the public in general to the purchase of unofficial and fake pamphlets, magazines, etc. In a majority of instances it has been found that the men wearing the uniform for peddling, hawking and panhandling on the streets and from door to door, are not bona fide soldiers but are using this method to take nefarious advantage of popular sentiment. This practice is in direct violation of the National Defense Act of June 3, 1916, and subjects the offender to punishment by fine of \$300 or imprisonment not to exceed six months, or both.

The real American soldier is absolutely and positively opposed to the use of the uniform for commercial purposes, because the sight of a soldier peddling, panhandling, canvassing or soliciting in uniform creates the fallacious impression that he has been neglected and is obliged to resort to the public through his uniform, to make a living. As one ex-service man puts it: "There are crooks and crooks, but about the meanest crook of them all is the crook who disguises himself as a soldier and, under cover of the glorious uniform, or even an imitation of it, swindles the patriotic with various unworthy money-raising schemes."

The War and Navy Departments are opposed to any such misuse of the uniform; the American Legion is opposed to it; the public should not encourage it.

HOUSEHOLD HINTS

A palatable way to serve cold boiled potatoes is to put them through a sieve, season them well with butter and salt, form into cones and brown in the oven.

If you use the starter for bread and don't happen to use it on the day you usually bake, try adding two heaping tablespoons of flour right in the jar, then after stirring well, put on more sugar. This keeps it fresh all the time.

Hang the garment on a hanger or dress form, tie a piece of rubber tubing to the spout of a tea kettle and train the steam on the material. With light brushing, many spots will be removed and the freshness of the garment renewed.

Dry mustard rubbed on the fingers after handling onions of fish removes the odor.

Avoid earthenware for keeping butter or cooking fat, as it absorbs grease. Use enamel ware or glass.

When pouring cake batter into a pan be sure that the middle of the loaf is lower than the sides.

If paint spots stick to the window pane dip a cloth in hot vinegar. The paint will come off beautifully.

Odors from deep frying of any kind are scarcely noticeable if a vegetable fat is used.

Salted foods should never be put away in aluminum utensils.

Soak handkerchiefs in a pail of salt and water before putting them into the ordinary wash.

Cottage pudding is really a one egg cake served hot with a sauce, and it may be varied greatly.

Oil of lavender on a bit of cotton will sweeten the air in a room where odors of cooking have penetrated.

Before blacking the stove rub the top with the rind of fat pork; then black. It will stay black longer and shine better.

Nearly all kinds of mottings or basket work can be cleaned by washing in salt and water.

When making cake always add two tablespoons of boiling water to the butter and sugar mixture. This plan secures a fine-grained cake with less labor and in no way interferes with your usual recipe.

Castor oil, as warm as the hands can stand, is very good for restoring softness to leather. Rub in with a soft cloth.

If soda is applied to a fresh burn it is less painful and less apt to blister.

Egg shells crushed and put in glass bottles with warm water will clean and polish the bottles beautifully.
