SHALL PACIFIC COLLEGE GO FORWARD

S. L. Parrett, Secretary of Business Men's Committee Makes an Appeal.

The present campaign of Pacific College for increased endowment has the full indorsement of the business men of Newberg. The history of Newberg is inseparably linked with the history of Pacific College. A study of her growth as she has gradually forged ahead of the towns surrounding her, reveals the fact that Pacific College is one of the prime factors in that growth. Pacific College has helped Newberg attain her present place among the cities of the Willamette Valley. Newberg needs her help in holding that place and in making the growth we all believe she is going to make in the years before us.

The following resolutions adopted by the Commercial Club are representative of the attitude of the citizens of Newberg to this campaign.

Whereas: Pacific College is undertaking in connection with the Inter-church World Movement, a campaign for an increased endowment, the success of which campaign will make it possible to standardize the college, thus increasing its value and efficiency, and

Whereas: Present conditions in the field of education make it necessary that Pacific College shall be standardized if it shall continue to exist, and

Whereas: Pacific College is recognized as a worthy local institution, playing its part in the development of our city and community, and bringing a large volume of business to our city every year,

Therefore Be It Resolved, That we the Commercial Club of Newberg, Oregon, do endorse this campaign, and call upon the people of this community to lend it their hearty support, and

Be It Resolved Further: That the President be authorized to appoint a committee to assist in this campaign.

What Is The Value of Pacific College To This Community.

The value of a college to the local community is not wholly a matter of dollars and cents. There are many things that money cannot buy and for that reason money cannot always bring them, and in such things as these, the contribution of a college to a town is rich. But Pacific College does bring business to Newberg. Every student brings from four to seven hundred dollars to Newberg each and Pacific has more than one hundred. Figure it up for yourself. You will not be able to make it less than forty thousand dollars in annual business. But that is on the present basis. The larger Pacific becomes, the greater will be its value as a business asset. Furthermore, a college advertises the town. Every athletic contest gets the town publicity. It is a fine thing to be known as a college town. In every such town can be found numerous families who have moved there, drawn by the advantages offered by the college, and Newberg is no exception in this particular. Letters of inquiry come to the office constantly asking about the town and the opportunities for various lines of business and industry. The college brings business, the college draws or helps to draw families who locate here. The alumni of the college are scattered over the state and they are all interested in Newberg because it is the home of Pacific College. The college is a most desirable institution for every home in Newberg, but especially for the homes with children. To be able to give your boy or girl a college education and have them at home in the meantime is most ideal. To such families Pacific College will save hundreds of dollars each year for each child attending her classes. Families resident in a college town have the further advantage of being able to keep their girls and boys under parental supervision and guidance.

Incidentally, the success of the campaign will greatly enhance the prestige of the college and greatly increase her efficiency, but its chief purpose is to standardize it. The need of standardization is no mere

talking point for the campaign. The leading business men of Newberg are agreed in saying that it is necessary to the continued existence of the college. It is necessary in order to hold the upper classmen in the college and to bring the prospective freshmen to the college as well. Pacific College has made excellent progress under a great handicap; it is the purpose of this campaign to remove this handicap and give her a fair show for development.

The present is the time for this campaign for various reasons, chief among them being the fact that the condition of the college will not permit of longer delay. It is a time of great interest in education and young people everywhere are flocking to the colleges. That the general public is interested is proven by the recent vote on the tax measures of the state which provided for the raising of additional funds for the state institutions. The spirit of cooperation in the city and community was never so good as now. Added to all these considerations is the promise of substantial help from sources outside of the regular constituency of the college. Altogether the situation compels the conclusion that now is the time to standardize Pacific College.

The campaign has as its goal the raising of a sufficient sum to standardize the college. This will take at least \$150,000. No smaller sum would make it possible to meet the necessary expense incident to properly maintaining the required course and equipment. It is felt that the local community can well afford to raise \$50,000, one half of which has already been pledged by the local members of the Friends church. This is about the usual proportion for the local community in campaigns of this nature. This means that \$100,000 or more will come to Pacific College from sources outside of the local community. This money will constitute a permanent asset to the community. Not only will the income from it be spent here, but the principal will be available as loans for the development of local industries.

Terms: The pledges are payable in four installments.

The first will be due September 1st, 1921, the second September 1st, 1922, the third September 1st, 1923, and the last installment September 1st 1924. In order that the college may be standardized soon, the pledges will bear interest at five per cent after January first, 1921, on all deferred payments. All unpaid installments will bear seven per cent after they are due. Liberty bonds will be accepted at par. The college agrees to standardize within a reasonable time, and of it fails to do so, agrees on request to cancel pledges and return all money paid. These conditions are the product of the business men's committee and fully protect the interests of the subscribers in the campaign.

GOOD NIGHT'S WORK FOR PACIFIC COLLEGE

Twenty-five Thousand Dollars Subscribed at Meeting Held Last Thursday Night.

It was a quiet gathering of members of the Friends church, with the members of the faculty and student body of Pacific College, that assembled at the local church on Thursday evening of last week, but subscriptions to the amount of \$25,000 were taken for the college before the company dispersed.

Dr. W. V. Coffin, representing the Educational Board of the Five Years' Meeting of Friends church, presided, and a short devotional exercise was conducted by Dr. A. Rosenberger, of Whittier College, California.

Representing the student body, short talks were made by Miss Esther Terrell and Zenas Perisho, they being followed by Pres. H. E. McGrew, of Penn College, Iowa, and former president of Pacific College, each of them emphasizing the urgent necessity for the standardization of Pacific College at as early a date as possible.

The task of taking the subscriptions devolved upon Rev. Charles O. Whitely, who proved to be the man of the hour, for he staid with it until the goal of \$25,000, which had been set, was reached. Aside from the student body the attendance was not large, but it was an earnest body of people who were impressed with the urgency of the situation and who were willing to do their best in an effort to relieve the pressure.

With this encouraging beginning the campaign for funds will be continued throughout the Northwest.

A business men's banquet is being arranged for Friday night at the Imperial hotel when a campaign for additional subscriptions in Newberg and community will be inaugurated. Unfortunately, U. S. G. Miller, chairman of the business men's committee and one who has been taking an active interest in the matter, will not be able to attend the banquet or take an active part in the campaign, owing to his illness, but Mayor Calkins will take his place and push the work. With a strong pull together Newberg will make an excellent showing, the goal being the standardization of the college.

The Christmas beeves provided for the consumption of Newberg's citizens are now in the cold storage department and will be on exhibition at the meat market on Friday or Saturday, and are a sight worth going a long distance to see.

The cattle were raised in Yamhill county and were fed on grain four months before being slaughtered. The animals, three in number, were thoroughbred Herford stock and had attained a size of nearly 1,500 pounds each.

This choice meat was dressed and prepared for the shop by John Mayer, the most skilled welder of a butcher knife to be found west of New York City, and we will wager a beefsteak against a nickel that every person who sees those Christmas beeves while on exhibition, will agree without a dissenting voice that Mayer is a real honest-to-goodness artist even if his pictures are made with a knife instead of a brush.
