NOTES FROM OREGON GROWERS COOPERATIVE ASSOCIATION

The Willamette Valley will hereafter be known as one of the western centers for broccoli growing. About 200 acres will be planted in Polk and Marion counties within shipping distance of Salem. The Independence growers will probably put in 50 acres this season and farmers living near Dallas will probably plant a sufficient acreage to make that city a shipping point.

The severe winter storms of April 15 did additional damage to the fruit crops of the middle western states. These crops had already been injured by frosts during the first week in April. In general, fruit conditions in the east and middle western sections, including Michigan, Illinois, Missouri and Arkansas, are far below normal. All report serious damage from cold weather.

Petite prunes grown in the Umpqua Valley, which have been sort of the under dog in the prune market, are now coming into their own. Packing and shipping under the "Truewest" brand, the Oregon Growers' Cooperative association has not only found a favorable market but in some instances, the Douglas county petites were preferred to the Santa Clara fruit. The association has found a market for all petites of its members. But until the association developed the market, petites grown in Oregon went begging.

To aid the Chinese Near Relief fund, the Oregon Growers' Cooperative association has offered to pack contributions of prunes at cost for those who are not members of the association. For its own members who wish to give prunes to the starving Chinese, the association offers to deduct from grade sheets. Prunes given for the Near East Relief fund will be sold and the money telegraphed to China for immediate use. If prunes donated to China were shipped, it would require two months or more before arrival, too late to help the thousands who are starving.

Members of the Oregon Growers' Cooperative association have received notice of the annual meeting of the association, to be held next Tuesday morning, April 26, at Salem, in the Masonic Temple.

This meeting will be of more than usual interest. R. C. Paulus, sales manager, will make a complete report of all sales made the past year and unusual market conditions. The treasurer will make a financial report and there will be full report of new memberships.

Of special interest to members will be the full discussion of plans for the association during the coming year. As other matters of importance will come before the members, it is thought this meeting will be more largely attended than any former sessions.

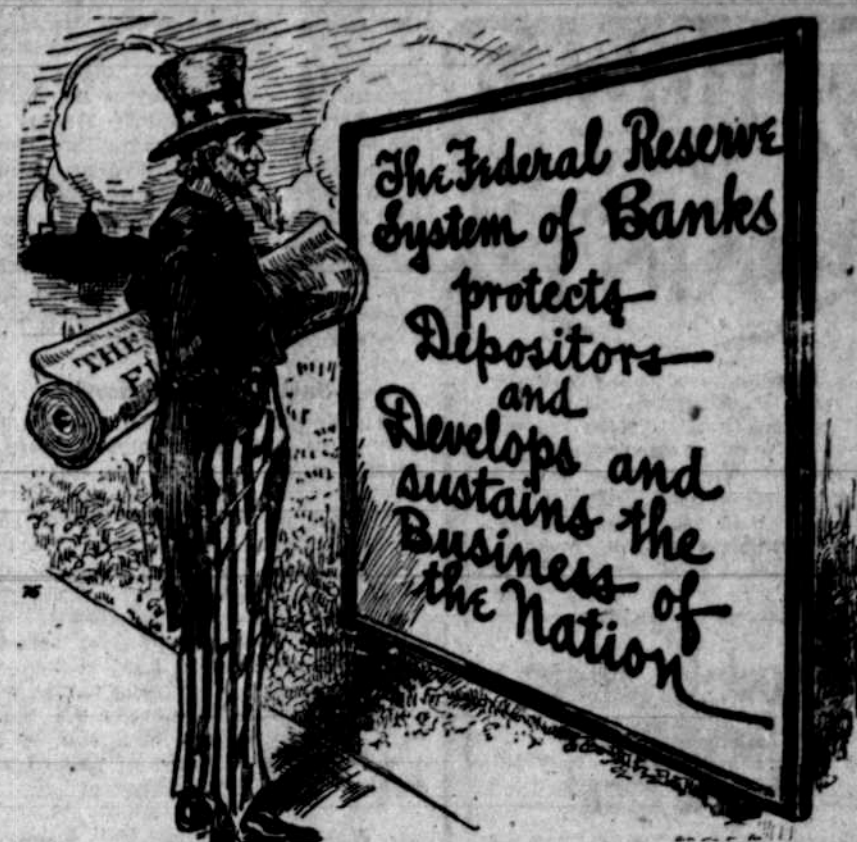
