**MORE ABOUT HIGHWAYS**

The Telephone-Register takes the Graphic to task for its editorial regarding the Willamina-Sheridan road bond election. In doing this the T-R tries to give the impression that McMinnville has never done anything to warrant the Graphic's laying the blame at her door and that Newberg and the other outlying districts are getting as much from the county court as is she herself. We wonder. We looked at the map the other day and noted, that in spite of the fact that the Lafayette road was designated by the state highway commission as the official west side highway, McMinnville's paved road by way of Dayton was being put through and thus McMinnville is to get two paved routes. We can understand McMinnville's desire to have two paved routes and we can appreciate her willingness to forego the pleasure of helping make good roads in other sections of the county, but she should not blame these other sections if they too want good roads and if they too retaliate and refuse to grant her request for pavement.

Would the Telephone-Register sit contentedly by and watch funds from the general county fund be diverted to the road fund in order that a three mile strip might be paved out of Newberg toward West Chehalam, or Springbrook or some other community which was not on the main highway, as designated by the highway commission, we wonder? Would they be willing to go without good roads in their own community and help vote good roads for others under such conditions? And yet that is practically what they are asking of almost every other section of the county.

Yamhill county's roads are a disgrace, as the Telephone-Register says. They are sadly in need of attention and the county court should see that something is done to relieve the situation. The Telephone-Register seems to think that it has presented an unanswerable argument when it mentions the mountain road up from Springbrook as an example to prove that we are getting good road money from the county, but does not the Telephone-Register know that this road would never have been put through at this time but for the fact that the farmers along its route and the people of Newberg and Springbrook and the Newberg Commercial Club joined hands and gave thousands of dollars

so that it might be built? They also point to the condition of the road between Yamhill and Newberg as being in good condition. If they had to travel this same road in winter they would not find it much of an argument in their favor, and just because it happens to be in good shape at this time is hardly an argument either way.

We are not opposed to good roads anywhere. We should like to see the people of the south end of the county have fine paved highways and we will do anything in our power to help them get them, but we don't propose to be ignored year after year as we have in the past and then turn around and feed the mouth that is biting our hand. It's all very fine to talk about the value of good roads to the county when you need them, but show us a little co-operation in other parts where they are also needed and we will feel more like helping you get yours. There will be some elections coming off in a few years and unless the Graphic is greatly mistaken in the sentiment of the people, there will be some surprises in store for old gang politicians in Yamhill county.

**WHAT OF THE FUTURE**

Many of the berry growers are asking this question in regard to the berry industry and in the light of present conditions it is a most important question to consider. However, every grower should bear in mind the fact that it is not only the berry industry which is experiencing a slump in sales and prices but every producer is up against the same condition. The low price and lack of market which faces the berry grower also faces the hay man, the wheat man, and in fact every one who is on the producing end.

There are vast sections of the country that are far worse off than is the Willamette valley in this respect and there is little, if any, doubt that with another and succeeding seasons this condition will be improved both in the berry and fruit industries and in all other producing industries. The granaries of the world will call for replenishment and with the readjustment period tided, things will assume a more normal aspect in all lines.

It would be folly for the berry man, the cherry man, or the prune man to become discouraged because prices are low and markets difficult to find this year, and plow up his vines or cut down his trees. The man who wins is the man who sticks it out through the hard times and is then in a position to take advantage of better times. Of course there are bound to be better times in the years to come. There is no overproduction for in fact in many sections there is actual want for what may go to waste in this wonderful producing section. It is a question of distribution and with lower freight rates and lower producing costs, this difficulty will to a large extent be overcome.

Every fruit man should see the rainbow of promise in his sky and plan for the future. It is certainly

no time to extend one's acreage of berries, but on the other hand it is no time to retrench in this respect. The wise grower will maintain his orchard or his berry patch as near its present stage of production as possible.

**GOVERNMENT WASTE**

The Tualatin Valley News hits the nail on the head in the following editorial. We have been of the same opinion and had intended writing an editorial along this line ourselves, but as brother Kautzman beat us to it, we will use his.

"When will the day arrive when newspapers will not be tormented with circular letters from a thousand and one 'bureaus'? Some of them read 'please publish without expense to the government,' and others from some organization in the background to become enriched by sponging 'please mention names and purport of our organization in your valuable columns.' The News is not beating the drum very loud for dead-head advertisers, government or any other kind. And they generally wind up with 'please send marked copy of your paper with our mention in same.' The only relief an editor has from such advertising dead-headers is, that the circular letters make news wrappers and saves cost of buying them."
