FRUIT MARKETS.

The Graphic believes that there is a wonderful possibility in shipping fresh fruit from Newberg to the desert regions and the middle west, which sections cannot compete with us in these products. There is a large section of country to the east and southeast of us which is absolutely non-productive as relates to fruits of various kinds. This section should afford our fruit growers excellent markets for their products, bringing them much better prices than they can ever hope to get in any other way. There should be no hesitation on the part of the farmers about endeavoring to create these markets for they will prove ultimately to be the best thing which they can do for the community.

Mr. Ed. West has developed a splendid market for his new Burbank standard prune, which he can ship in the fresh state by express shipment clear across the nation. Similarly, berries, apples, peaches, pears, and all fruits grown here can find a wide market by the careful picking, sorting, grading and packing of the fruit. Newberg farmers should begin to cooperate along these lines and learn from the experience of others that our problem is not nearly so much a matter of over-production or under-consumption as it is a problem of improper distribution.

Why pay exorbitant sums to the middle men and allow them to dictate prices and then kill the profits by culling the fruit sent out. Why not cooperate and send our man in to these territories and establish markets direct, as was done by the Springbrook berry men last spring. Do we hear some one say it can't be done? If some one doesn't spring that old hackneyed phrase, it will be the first time that anything was suggested, when some one did not rise up with a long string of objections.

We see no reason why the farmers and the fruit men should go on accepting a mere pittance for their fruit, when in nearby sections people are paying such prices as \$4 and \$4.50 a box for pears, when they have to pay 20c a small tray for loganberries, and when cherries sell at 35c per pound. Why should not the fruit men get in touch with these markets and while reducing the cost of this fruit to the consumers there, at the same time raise the price which the producer is getting. We see no reason why it should be necessary for several middlemen to step in and make a fortune between the price paid the grower and that paid by the consumer.

Take the case of one small city

in Nevada. We knew of one store which imported a carload of fresh fruit every week. Multiply this by hundreds of such towns and by several such stores in each town and you have a total which should take care of far more fruit than can be raised here. But that need not alarm any one, for if the demand exceeds the supply, then much of the land which is now lying idle will naturally be put into bearing and we shall have increased population, increased production, increased prosperity and in fact an increase in everything to be desired.

But some one will say, "What about the cannery?" We believe that the cannery people will agree with us that anything which will cause greater satisfaction among the fruitgrowers will in turn be of help to them. With more people raising fruit, there will be more fruit to can and a better chance at selection on their part. Fruit that will not do for canning so well, will be shipped fresh, while fruit that cannot be shipped may be canned, and thus the one will simply coordinate the other.

There is not a person here who has not at some time sent a sample of our local fruit to some friend in the east or middle west. Nearly always, if care has been shown in the selection of the fruit and the packing of it, expressions of praise from the recipients are the consequence. Oregon fruit is becoming known everywhere for its fine flavor, size and coloring. The reason is to be found in the supreme excellence of the fruit itself. There is no reason why this should not be capitalized on the part of the grower. Apparently the matter only lacks some one to start it.

Mr. West has demonstrated its feasibility with his prunes; Mr. C. W. Smith also demonstrated it with his berries; the Springbrook growers demonstrated it with their berries. Why not extend the scope of this work and create extensive markets for our fruit, berries, etc., at better prices than now prevail. The Graphic is ready to do anything possible to aid such a movement, and we hope that the Farmers' Club, The Berrians, or some persons or organization will take up the matter.

The Oregon State Fair is a splendid institution. Here the products and resources of the entire state are displayed to their best advantage so that strangers may know what is raised in the various sections of the state and so that by comparison, the people of the state may learn lessons in what they can do. The sections of the state should take a very active interest in this fair and make sure that their own resources and products are properly represented. The Oregon State Fair is always worth while and should call out a large attendance from this community as it no doubt will.

Next year send a crate of fruit to your friends in the east or middle west. They'll appreciate it and you'll be helping to advertise your community in the best possible way.

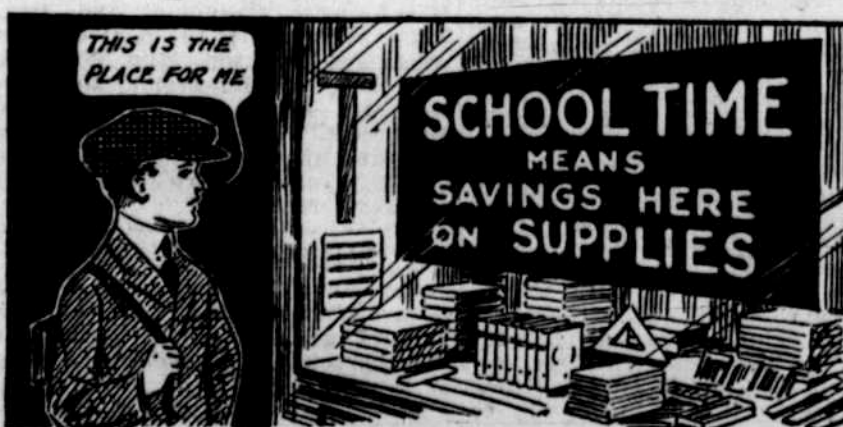
