BE A BOOSTER

How do you rate in your community? Are you a booster or a knocker? Are you a community asset or a liability? The answer depends entirely upon yourself. Think over the people of the community with whom you are acquainted. They will naturally fall into one or the other of these classifications and you will readily recognize whether their living here is a help to the community or whether they are a hindrance.

The world needs boosters. Men and women who are willing to see the bright side of things and who refuse to look at the dark side. Men who attend to their own business and strive to improve it and let the other fellow do the same. There are always those who go about telling how their competitors are scoundrels and hypocrites, but they will never help build up either the community or their own business in this way.

It has been said that competition is the life of trade and to a certain extent this is true, although it may be carried too far. Certainly unfair criticism and backbiting methods of competition are not the life of any trade, and these practices only tend to disgust the public and make them feel that business men are all crooks.

And so it is in community affairs. We need to forget petty personal elements and overlook them and get our shoulders to the wheel and push. What a wonderful thing it would be for Newberg, if everyone in it were boosting for this city and its advancement. A great many people are and because of that fact Newberg has a reputation over the state enjoyed by few other cities of her size. However, if everyone could only lose their hammer and become boosters this condition would be still further improved. What Newberg needs is more boosters and less knockers.

President Harding has set aside the week of April 16-22 as Forest Protection week, and the U. S. forest service is issuing a call for renewed care in fire prevention. We have only to observe some of our best scenic spots as they were some years ago and then again as they are now since having been denuded of forests by fire to realize the importance of this movement. Around Government Camp at Mt. Hood one sees one of the most striking illustrations of this condition, where dead trunks and barren wastes have replaced the beautiful green of virgin forests. And it is only too true that a great portion of our forest losses are due to carelessness. It is certainly time for a warning. In accordance with the request of the service the Graphic is publishing this week a number of slogans and short items calling the attention of the public to this carelessness and its effects.

Only a man in a forest green.
Only a match that was dropped un-seen.
Only a flare—some leaves and wood.
And only a waste where the forest stood.

CAMPING, HUNTING AND FISHING GUIDE ISSUED

"Camping, Fishing and Hunting Guide" is the title of a sports booklet reissued by the Southern Pacific lines with the aid of the U. S. forestry service.

It has a very striking cover in four colors; is nicely illustrated with sketches and maps; contains articles on the playgrounds in western Oregon, within and without the national forests, and directions as to reaching the hunting and fishing places; how to make camps, and what to use in doing so. It tells about roads and trails; outfit and clothing; food supplies, recipes, cooking equipment and how to use the cooking utensils. A part of the booklet is devoted to packing; protection of game and fish; the handling of killed deer; how to rescue, revive and carry injured companions; prevention of forest fires; game laws and licenses, and a number of other interesting points for an outing.

"Rules for sportsmen," "Sky-Line Trail," "Beach Resorts," "Foot-hills of Western Oregon," are headings of some other portions of the booklet.

FOREST PROTECTION WEEK SET FOR APRIL 16-22, 1922

By the President of the United States of America, A Proclamation:

Whereas, the protection and perpetuation of our forests are vital to our continued industrial welfare and national strength and to our individual-braska observance of a day especially and

Whereas, a period of fifty years has passed since in April, 1872, there was instituted in the state of Nebraska observance of a day especially set apart and consecrated for tree planting and known as Arbor day, and

Whereas, both through wide spread annual celebration of Arbor day and through the increasing observance of Forest Protection Week public attention has been commendably directed to the value of trees, the unnecessary waste of our diminishing forests through preventable fires, the deplorable effects of forest devastation and the need for remedial measures against depletion of an essential national resource.

Therefore, I, Warren G. Harding, President of the United States, do urge upon the governors of the various states to designate and set apart the week of April 16-22, 1922, as Forest Protection Week, and the last day of that week, April 22, as the golden anniversary of Arbor day, and to request officers of public instruction of counties, cities and towns and of civic and commercial organizations to unite in thought and action for the preservation of our common heritage by planning such educational and instructive exercises as shall bring before the people the disastrous effects of the present waste by forest fires and the need of individual and collective effort to conserve the forests and increase our tree growth for ornament and use.

In witness whereof I have hereunto set my hand and caused the seal of the United States of America to be affixed.

Done in the District of Columbia, this 31st day of March, in the year of our Lord One Thousand Nine Hundred and Twenty-two and of the Independence of the United States of America the One Hundred and Forty-Sixth.

NOTICE TO OWNERS OF DOGS

It is unlawful in the State of Oregon for any person to keep a dog of any description over the age of eight months without first paying the license fee thereon to the County Clerk. The fees for said license are as follows: Male \$1.00; Female \$2.00; Spayed Female \$1.00.

Section 9, Chapter 186, 1919 Session Laws provides as follows: The County Clerk shall keep a record of the issuance of dog licenses in a special book kept for such purpose. Any owner or keeper of said dog or dogs who shall fail or neglect to apply for, or fail to pay said license fee during the month of January in each year, or within thirty days after he becomes the owner or keeper of said dog or dogs, shall pay a fine of ten dollars (\$10) for each offense, which fine shall be collected with costs of the proceedings of a civil action in the name of the state of Oregon before a Justice of the Peace. Neglect to apply for or pay said license fee for a period of thirty days after said fine shall become due, shall be another and separate offense and will subject the person to pay an additional fine for each offense.

If you have not complied with this law you had better do so at once. AFTER APRIL 15TH, I INTEND TO ENFORCE THIS LAW TO THE LETTER IN YAMHILL COUNTY.
