WHICH DO YOU PREFER?

We often hear people say, "I would rather buy in Portland for one has so much better selection there." We wonder what the state of their reasoning is, for if everyone adopts that idea trading in Portland will not only be a matter of choice but of necessity. The local stores provide an accommodation which should be appreciated by the public. It permits them to buy their supplies without the necessity of going a long distance and buying from strangers. Newberg merchants could carry large and representative stocks of goods in all lines if everyone were loyal to them and purchased their supplies here at home. However, if there is an increasing tendency to trade in Portland they must continue to curtail their local stocks and the selections will become less and less satisfactory.

It is a matter of real convenience when one needs a new hat or a new pair of shoes to step into a local store and make his purchase. Here one knows the man with whom he is dealing and feels sure that he is going to try and please him in order to get him to return. Here one can say charge that to my account, if he has not the change with him at the time. Here one can say just send that up to the house and avoid carrying his purchases. But in Portland he has none of these convenient arrangements.

Then if one buys an article of Bald or Porter, Miller, See or Oberg or any of the other local business houses he knows that part of his money comes back into the community and helps build up Newberg. However, if it is spent in Portland he cannot expect any such return. The man or woman who says "I would rather buy in Portland," does not perhaps realize that they are helping destroy the conveniences of local buying and larger selections at home by so doing, but they are confronted with this choice, of either buying at home and supporting their local merchants and thus enabling them to carry good stocks, or of trading in Portland and eventually finding their local stores run down to the point where they will have to go to Portland for almost everything. Of course this is an extreme picture, but the practice carried to its ultimate conclusion means just about that.

OUR HIGHWAYS

In our last issue there was an article by C. W. Bradshaw regarding the trucks and the highways which was very pertinent. It is indeed a live question as to what we are to do about the rapidly deteriorating

highways. The highway between Newberg and Portland was of course one of the first laid in this state and was somewhat of an experiment. Probably it was poorly constructed. However, it has gone to pieces and is in very bad shape considering the money expended and the length of time it has been in use. The taxpayers who helped pay for its construction naturally feel that they have a perfect right to inquire what guarantee they have that other moneys spent for highways will not be wasted also.

We do not feel that the state would have any right to bar trucks absolutely from our highways, and yet, something must certainly be done to protect the taxpayers who have to pay for their construction and see that they are not torn up and destroyed in a short time. The matter of overloading should be given strict attention and a heavy fine with imprisonment should be imposed for violations of the law in this respect.

The highways were built for the general public and not for commercial purposes. The general public of course benefits to some extent from the running of trucks and busses, but if these are destroying the highways, their benefits will be more than offset by their losses. Furthermore, the big trucks with their ponderous loads also obstruct traffic on the highways and take much of the pleasure out of motoring by playing road hog. This is not universal but it is too common to be overlooked.

Some steps should be taken to solve the problem of traffic regulation and licensing, so that our highways may not be destroyed before they are hardly completed and so that the pleasures of motoring may not be lost to the general public.

What kind of a city would you rather live in? One that everyone says is dead or one that is noted for being alive and doing things. There are always a certain few who get in and do things and help keep their city on the map. But there are also those in every city who are willing to sit back and watch others work their heads off and then criticize them. Which class is yours? Just at present Newberg is enjoying a reputation for being alive and an up and coming city. What have you done to help it gain that reputation?
