Other nearby counties received apportionments as follows: Multnomah county \$66,353.23; Tillamook \$2,173.04; Washington \$6,735.64; Marion \$10,453.94; Clackamas \$7,133.83; Polk \$3,369.83.

The Oregon supreme court handed down an opinion on Tuesday in which they affirmed the decision of Judge Tazwell of Multnomah county in the suit brought by Winthrop Hammond to recover \$100,000 alleged to be due for services performed in connection with the guardianship of Thomas Prince, an incompetent person. At the time Mr. Prince died in Multnomah county the guardianship terminated and the court allowed Mr. Hammond \$25,000 in payment for his services. Mr. Hammond appealed from this decision to the supreme court. Mr. Prince was the owner of the large orchards at Dundee.

W. T. McNulty, employment representative of the United States Veterans' Bureau for Oregon, was a Newberg visitor on Thursday of this week. Mr. McNulty was formerly a resident of Newberg and taught in the commercial department at the high school in 1915. While here he appointed a local employment committee of the U. S. Veterans' Bureau whose duty it will be to try to find employment here for rehabilitated service men. This committee will consist of R. J. Moore, W. H. Woodworth, Chester A. Dimond and R. A. Butt. A meeting will be held in the near future and some plans worked out to try and further this movement locally.

Craig R. Butler, who has been selling his products on the Portland city market, informs us that a new ruling has been issued covering the selling of products on the market which eliminates the pooling of products by preventing any agent from selling for more than one person. This is done because the agents have misused their rights by holding up prices and controlling the stalls so that producers cannot get them for use. Some local people who have been selling through agents may find this new ruling against them but in the main it is thought to be a good thing. Under the new ruling it is also provided that no one but a producer can hold a permanent stall.

Mr. and Mrs. Jesse Edwards returned Tuesday from Elwood, Indiana, where they went on a visit to their daughter, Mrs. M. M. York, expecting to be there for some months. However, they found their daughter sick with the summer flu and the temperature never below 98 during the daytime for two weeks and decided to return to Oregon where they could get a good breath of fresh air. Mr. Edwards says that it was 107 in Chicago the day they arrived there and that even at nights the temperature would remain up to 90 and higher until nine or ten o'clock. Mr. Edwards says that they have a big corn crop and also a very large crop of tomatoes in Indiana this year.


City Marshal Ferguson had a busy time for a few hours Saturday afternoon. He arrested H. O. Sage and H. G. McGregor for drunkenness and placed them in the city jail and almost before he had locked the doors on them he was forced to arrest Martin Iverson, who lives on the mountain north of town and who gives the officers regular trouble by being drunk.
