Manager Laidlaw and Land Agent Cook Here--More Settlers.

Manager W. A. Laidlaw and Land Agent B. S. Cook, of the Columbia Southern Irrigation Company, arrived Monday from Portland and are spending a few days looking over the field work. They deny the report that E. E. Lytle and Walter Moore have sold their interests in the irrigation company. They are greatly pleased with the popular interest in Columbia Southern Irrigation lands and see great advancement coming for the region west of the Deschutes.

G. L. Simmons, of Rigsby, Idaho who was in and selected land some time ago, is now on the way back with a carload of stock and equipment for the new ranch.

When the Columbia Southern construction crew moved on down the line it left the Becker camp without a cook. Mrs. Arnold has now taken charge of the Becker boarding house.

Change at the Oregon King.

The Sumpter American speaks of the transfer of the Oregon King mine, the chief mining property in the Ashwood district of Crook county, as follows:

"The Oregon King mine, Crook county, which is pronounced by some who have examined it one of the greatest mines of the state, has been taken by the Geiser-Hendryx company, of this city. Albert Geiser, one of the members of the firm, is at the property this week, making arrangements for opening work on a larger scale, and effecting improvements that are contemplated with a view of increasing the output of the shipping product and concentrating the milling grades of ore.

"As an index of what the present management proposes to accomplish, Mr. Hendryx said that before the year closes he expected that the company would be sending from the Oregon King 50 tons of concentrates every day."

Manager Edwards and Superintendent Thomas, of the Oregon King, deny any knowledge of a transfer.
