AN ORDINANCE

To prescribe the method for giving notice of sidewalk construction.

Be it ordained by the Common Council of the City of Bend:

Section 1. That owners of real estate in Bend shall be liable for the cost of sidewalks on their lots in front of their premises when required so to do by the Common Council of the City of Bend.

Section 2. That thirty days after the giving of notice of sidewalk construction, the owner shall construct such sidewalk, and the cost of such construction shall constitute a lien upon the real estate of the owner, and shall be collectable as provided for in the ordinance entitled "An act for the sale of timber lands in the States of California, Oregon, Nevada, and Washington Territory," as extended to all the public land states by act of August 4, 1905.

Section 3. That notice of sidewalk construction shall be in writing and shall be filed with the recorder of the county of Crook, Oregon, and shall be served upon the owner of the real estate.
