

Delinquent Tax Notice.

COURT OF OREGON.

Notice is hereby given that payment to the tax executing issued out of the county court of the State of Oregon for the County of Crook, on the 1st day of October, 1905, and to me directed, commanding him to collect the amount of taxes, commanding him to serve a delinquent tax notice upon all persons delinquent taxpayers who are delinquent on the assessment roll for the year 1905, and will on Thursday, the 25th day of February, 1906, at the north door of the court house in the city of Prineville, Crook County, commence a suit at law for the amount, and will call all the rest of the delinquent tax payers for the said year, and the blinder who will offer to pay the amount of the taxes charged, together with the penalties, interest, and costs, and take a certificate therefor at the lowest rate of interest, not exceeding ten per cent per annum.
