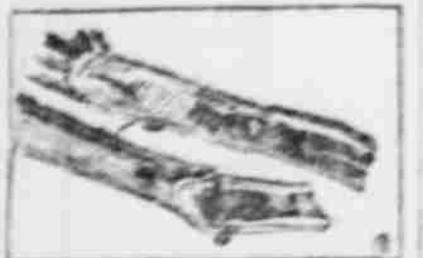




THE STALK BORER.
