## School Rules Published

Local Board and Principal Prepare Leaflet Upon School Management, History and Equipment--Great Growth in Few Years Time

The Board of Directors of the Bend Schools, co-operating with Principal Harrington, have drawn up and had published an extensive leaflet containing the rules and regulations of the Bend Schools and a brief sketch of the schools development. These are to be distributed to all patrons of the schools.

Below is given extracts from the leaflet, which will be ready for distribution the first of next week.

### General Rules.

1.—The school year shall consist of thirty-six weeks, and is divided into two semesters of eighteen weeks each.

There shall be a Christmas vacation of two weeks, unless otherwise ordered by the board.

There shall be no school on Thanksgiving day nor the Friday following; nor upon Christmas, New Year's and Memorial days; nor upon the twenty-second day of February; nor upon other days specified as legal holidays by the School Laws of Oregon.

The school year shall begin on the first Monday in September, unless otherwise ordered by the board.

2.—Daily sessions shall be as follows: Forenoons from 9:00 o'clock to 12 m., with an intermission of fifteen minutes, from 10:30 to 10:45; Afternoons from 1:15 to 4:00, with an intermission of fifteen minutes, from 2:45 to 3:00; provided that the intermissions may be omitted when the weather is inclement, or the grounds are not suitable for exercise. Pupils in the First and Second Grades may be dismissed at 11:30 a. m. and 3:30 p. m. daily.

Daily sessions in the High School shall be from 9:00 a. m. to 12:00 m., and from 1:15 to 3:40 p. m., with intermissions as above indicated for the grades.

All pupils enjoying good health may be required to pass out doors at intermissions, and may not return until the ringing of the bell, except by permission of their teacher.

When no intermission is given, the half-day sessions shall close fifteen minutes earlier than usual.

3.—The school buildings and grounds shall not be used for other than school purposes and normal institutes, without the previous consent of the board.

No advertisement shall be read, posted or distributed in any school room or building, nor posted or distributed anywhere upon the school grounds, except by permission of the school board.

4.—Examinations shall be held regularly at the close of each semester, all markings being upon the basis of 100.

Written tests and reviews may be given during each semester at appropriate times, no less than three such tests shall be given during each semester; the third written test of each semester shall be a part of the final examination, in order that pupils may write but one examination on each subject at this time.

Monthly report cards, showing the pupil's absence, tardiness, deportment and scholarship, shall be sent to the parents, which card shall be signed by the parent or guardian and returned promptly to the teacher.

The standings in each subject for each period shall be the teacher's estimate, which is the result of the written test, raised or lowered as the class-work for the period may justify; class work to count equally with the written test. The grades for not more than two months of each semester may be determined from class work solely. The standing for the semester shall be determined by adding the four monthly grades and the grade obtained in the final examination and dividing the result by five; or in the event that only four grades have been given during the semester, including the final examination, then the sum of the grades shall be divided by four.

No pupil, whose standing is under 80, is doing satisfactory work, and parents should aid in securing better work from such pupil.

Any pupil, whose class standing is 90 or more, may be excused from examinations, at the option of the teacher.

5.—Promotions shall be made at the close of each semester, when conditions warrant it.

If it is better, in the teacher's judgment, that the pupil should repeat the work of a given grade, he should do so. The pupil should work where he can best develop his powers. The teacher is the most capable of judging in this matter and the authority and responsibility largely rests with the teacher.

Individual promotions or demotions, however, shall not be made without previous consultation with the Superintendent. Neither shall any class be moved from their prescribed limits without his permission.

Regular promotions are based upon two essentials:

(A)—The final standing in each subject must be 70 or more.

(B)—The average of the final standings in all studies, including deportment, shall be 80 or more.

Pupils shall not suffer two consecutive demotions, except in extreme cases.

Pupils failing in not more than two subjects during the year, may be permitted to make up the work during the summer vacation, and pass examinations, in such studies, under the direction of the Superintendent, during the week preceding the opening of the next school year.

If the pupil fails in more than two studies, the work should be taken over again.

For special requirements for Eighth Grade pupils, see Oregon School Laws, Chapter IV.

6.—No regularly enrolled pupil shall be excluded from his classes, or from regular attendance, for more than one day, unless suspended by the Superintendent or expelled by the board.

7.—Systematic calisthenic exercises shall be given in all grades, both forenoon and afternoon, for a period of at least five minutes, when no recess is taken. Abundance of fresh air must be supplied during these exercises. See also, Section 64, Paragraph 8 of Oregon School Laws.

8.—Teachers shall be elected for a period of one year, and all salaries shall be determined at the time of election.

All re-elections shall occur not later than May 1st.

Vacancies may be filled by the board at any time.

### In Conclusion.

A word about the first school of Bend, and the rapid growth and development of our public schools may be of interest.

Twenty-five years ago the first school in this locality was established in a small log school house, which is still standing near the Deschutes river, about midway between the old towns of Deschutes and Lytle.

School continued to be held in this building until Jan. 1, 1903, when it was transferred to the building now used as the Catholic Church, and continued there until the present school building was erected in 1906.

Leaving the little log school house, with one teacher and a few pupils, eight years ago, there are at present ten teachers employed in the district, and the present total enrollment reaches about 190.

From a country school we have grown to a well organized graded and High school on a par with the leading schools of the state.

To Miss Ruth L. Reid (now Mrs. H. J. Overturf) belongs the credit of organizing the High School and bringing it to a high standard of excellence.

During the present school year three teachers are employed in the High School and classes have been formed for all the branches required by the State Course of Study for

High Schools of the First Class, giving a complete four year course.

Likewise classes have been formed for all the optional branches scheduled in the four year course, with the exception of two branches; classes not being formed in these because there were no applicants. The people of Bend now have equal advantages in the matter of educating their children from the primary grade to the completion of the High School course with practically any other locality in the state with the exception of Portland and a few of the larger cities.

In order to continue its growth and development, the following are the immediate needs of the schools: An additional supply of maps, globes, apparatus for the Chemical and Physical laboratories, and reference books.

After another year the present school building will not accommodate the pupils.
