

#### END CAME LAST WED-NESDAY NIGHT

Ill Since Last Spring, Aged Lady Succumbs to Stomach Trouble -Came Here Nine Years Ago -Leaves 7 Children.

With the death last Wednesday night at 10 o'clock of Mrs. Arnt Aune at the age of 66 years, Bend lost another of its pioneer citizens. Mrs. Aune had been in poor health since last spring, succumbing to stomach trouble. The remains were interred Saturday in Pilot Butte Cemetery.

Nine years ago, when there were, only a few scattered houses where the town stands, the Aune family came to Bend from Michigan, and Mrs. Aune had made her home here ever since. The family home was the second residence erected in the town

#### Born in Norway.

Mrs. Aune was a native of Norway. having been born at Thronhjen on October 2, 1845. Until a year ago she enjoyed good health. In April she went to Tacoma to have an operation performed, but it was of little avail and she gradually grew worse. Knowing that the end was not far off all her seven children gathered at the home and were with their mother when the Death Angel passed over the threshold. She is survived by her husband and the following children: Mrs. Bert Nelson of Pequaming, Mich., Ralph Aune of Tacoma, Misses Caroline and Maggie Anne, Mrs. Oliver Johnson, Theodore and Anton Aune of Bend.

The funeral was conducted from the residence Saturday morning at 10:30 o'clock by Rev. M. W. Weaver of the Methodist church. Special songs were sung by Mrs. Z. W. Lindborg, Miss Iva West, C. H. Hunter nd O. A. Thorson, makink the services most impressive.



Pine Forest Irrigation Co. Stockholders Elect Directors.

At the annual meeting of the stockholders of the Pine Forest Irrigation Co. Saturday, directors for the ensuing year were elected and other business transacted. The following men compose the board: C. D. Rowe, Glenn H. Slack, Ernest Garrett, W. F. McNaught and W.? J. McGillvray.
