WATER FIRST, SALES SECOND.

Settlers and those who have come into close contact with Oregon irrigation are disposed to applaud the action of the state engineer—an action apparently backed up by the entire land board—in refusing to certify to a patent list involving some 26,000 acres, because complete reclamation had not been accomplished. Shorn of its technicalities, the meaning of the matter is this: The Central Oregon Irrigation Company desired permission to sell these acres, or to get patent to them; the state engineer refused to make such permission possible, contending that the land should not be offered for sale until there was positive assurance both of a sufficiency of water to care for it, and that this water was ready to be placed on the lands.

The principle involved is an old one in Western irrigation. In countless cases the companies have been permitted to sell land before they were in a position to deliver water to it. The plea usually has been that water was "practically ready", and that the money from the sales would make possible the completion of the project—this with variations. After failures galore, after highway-robbery promotion and official milking of company administrations and, especially, after a vast amount of needless and cruel suffering on the part of settlers, there is manifest a disposition on the part of the responsible officials to insist on this all-important fundamental law: Let no land be sold unless there is water ready for it.

Enforce this law to the letter, and irrigation will be a success for settler and investor.

THE ROAD WORKERS.

A short time ago citizens of Pineville turned out as road workers. They wanted to improve a highway south, and so they went out and improved it. About a dozen auto owners contributed the free use of their services. The county tools and camp equipment were borrowed. Only \$250 of actual cash was involved, and this was secured from the County Court. Then the "road gang" went out and stayed out for a week, removing many rocks and improving the bad places. Altogether, it is estimated that the equivalent of several thousand dollars worth of improvement was effected. For instance, the auto running time from Millican's to Pineville was cut close to an hour. There is a moral for Bend in this example. The Lord helps those who help themselves, but certainly neither the Lord nor anyone else seems disposed to do much about the frightful roads that lead from Bend southeast, east and north, unless Bend get on the job first.

The county budget calls for \$5000 for widows' pensions. Even for a county where the administration is notoriously kindly disposed to widows, that seems a bit high. Soon it will be cheaper for a woman to be a widow than to support a husband.

Harney County's budget totals \$138,516. Crook County's is \$287,393.
