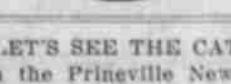

LET'S SEE THE CAT. Again the Prineville News is silent. None of those exposures regarding county affairs appear.

Perhaps somebody has pointed out to Editor Pollard the folly of his staff. Perhaps—oh horrible thought—the News is subsidized too!

The News was going to rip things wide open. The lid was to be lifted and the public at last shown the horrors beneath it.

But the News still gives no news. Its last editorial is carefully colorless, concerning New York gun men; as a topic polar exploration would have been about as pertinent and intimate.

However, under the subterfuge of a letter, nominally written by W. H. Lucy, it slides a little mud at the County Court (excepting the Judge, of course), at the Sheriff, District Attorney and the editors of The Bulletin, Pioneer and Journal.

Mr. Lucy, we gather from the tone of his epistle, is training in the Springer correspondence school.

That, however, is beside the issue. We are interested in that cat. Won't you please, Mr. Pollard, let him out of the bag? Consider those farmers, craving for truth, and anger these questions:

Who are the "subsidized press"? Who subsidizes them? How is it done? What news is suppressed? What are your objections to Frank Elkins? To Warren Brown? To W. W. Brown? To Willard Wirtz? To H. A. Foster?

For whom should we vote for Sheriff? For Commissioner? For Clerk? Briefly, we, too, crave information. We desire to see the color of that poor, suppressed Court House cat.

If there is aught in you, Editor Pollard but buncombe, we, and the public desire to know it. Perhaps we misjudge you. If so, put us right. And if you would not entirely discredit your newsless News, you must now stand forth upon your own feet, abandoning tricky innuendoes, and saying exactly what you mean.

USEFUL EULOGIES. From the Congressional Record of April 19:

"There shall be printed of eulogies of deceased Senators, Representatives and Delegates, 6,000 copies, of which number 50 copies, bound in full morocco, with gilt edges, shall be delivered to the family of the deceased and 1,950 copies, in cloth binding, shall be delivered to the Senators, Representatives, or Delegates of the State or Territory represented by the deceased.

The remaining number, also in cloth binding, shall be distributed in the proportion of 2,000 to the Senate and 4,000 to the House." Oh Death, where is thy sting? And incidentally it may be noted that eulogies of the dead become campaign ammunition for the living, along with printed speeches, which may or may not have been delivered, seeds and governmental reports, all of which delight the heart and flatter the vote of the constituent back home.

SAVE THE FISHING. A little effort made now will insure the repeal of the present trout fishing law for the Deschutes. As it is, anglers can fish all the year; they simply are supposed to keep nothing under ten inches in length.

As a result, the trout are being attacked all the time, those smaller than ten inches are actually being kept, and propagation of trout is being checked through the killing of egg bearing fish.

Everyone who loves fishing and desires a maximum of sport in the Deschutes should back up this move. April is time enough to commence fishing; one can get plenty of recreation during the summer. If the original fish season can again be enforced, there will be more fun for anglers, more attraction for visitors, and more business for those who sell tackle than can ever be the case if the present destructive method be followed for another season.

The Land Board is to be commended for its action in placing John Dubois here to make a thorough survey of Central Oregon Irrigation Co. ditches, canals and laterals. The data thus secured is to become a foundation upon which will be based future discussion in regard to seepage and other problems. Such information, authentic, accurate and trustworthy, has long been needed. Certainly the Board never took a more intelligent action.

MEXICAN SITUATION EASIER

Summary of Recent Events in the Southern War Zone.

Developments in the Mexican situation in the past week lead to the hope that matters may be settled without war. The South American republics, Argentina, Brazil and Chile, known as the A. B. and C. of that continent, through their diplomatic representatives at Washington, offered their services toward mediation between the United States and Huerta and President Wilson promptly accepted. Later Huerta announced his assent to the proposal and it now remains to take the next step.

Before the offer of mediation was made the United States marines had landed at Vera Cruz under the protection of the guns of the warships in the harbor and taken possession of the city. The Mexican forces under General Maas withdrew into the hills about 20 miles away. The Stars and Stripes were hoisted over the city yesterday.

On the occupation of Vera Cruz all the Americans in Mexico City started to leave for the coast and several train loads have come through. Among the Americans was charge d'affaires Nelson O'Shaughnessy who had been the representative of the United States in Mexico City since the removal of Ambassador Wilson some time ago.

Rioters in Mexico City have attacked the American consulate and torn down a statue of George Washington but there are indications that the better classes are now getting control of the situation and will stop further violence.

The attitude of the rebels under Carranza and Villa has been the subject of much anxiety on the part of President Wilson, the former showing an indication to make common cause with Huerta against the Americans, while Villa announced his sympathy with the United States. It is not expected now that any volunteers will be called for from the states.
