A FAIR FIGHT.

"It is better to have loved and lost than never to have loved at all," is an old saying with merit.

Equally true, it is almost better to lose a fair fight than to win unfairly.

We do not believe that we shall lose the county division fight. On the contrary, we are convinced that we shall win it, although probably by a narrow margin, and indications and reports from all precincts substantiate that opinion.

We are optimistic firstly because we believe that every resident of the proposed Deschutes county is selfish, just as we are. Being selfish, each will do what will benefit him or her most. And after sane study of the facts, no one can help feeling that all portions of Deschutes county will be benefited by division.

That is one reason for optimism. It is based upon a sincere belief in the merits of the case, and confidence in the good judgment of the voters with whom decision rests.

The other prime reason is that the fight for division has been conducted along fair, clean lines. Nothing has been said, and nothing has been printed, of which any of the pro-divisionists should be ashamed. Whatever the outcome, there need be no apologies and no explanations after November third.

The figures tabulated by the division workers are absolutely accurate, and their arguments are founded on facts. That is why opponents of division have been unable to contradict them, and instead have resorted to personalities and attacks actuated by community jealousy or motives of personal gain.

No logical reasons have been produced against division. Anyone who will study the question dispassionately can see that division means economy and direct benefit to the west side of the present Crook county. Votes should be cast solely with an eye to the benefit to the voter, and unobscured by the poison of illogical hostility.

We regret the opposition, of course. It is regrettable—and yet it is laughable! Redmond, four years ago a champion of division, now struggling against it because the time is "too early!" Redmond men campaigning against division, and in the next breath admitting that they would favor it could Redmond get the county seat! Redmond attempting a trade with Madras, offering its votes to Jefferson county if Jefferson would knife us, and then going out in Deschutes county and arguing against division!

Whatever the outcome, that species of opposition must prove disastrous to those who stoop to it. And surely, if we continue to stick to facts and to creditable methods, we can face our friends and our opponents with a clean record, prepared either to take up the administration of Deschutes county in a fair way, true to our pledges, or to battle further for the establishment of a west side county later on.

FIGURES TELL TRUTH (Madras Pioneer.)

It is a fact that there has not been produced as yet any sound logical and plausible arguments against division, either by any of the tax payers opposing it, or those who have been attending the meetings from Prineville.

There has never been any printed matter produced with figures against division, and what figures that have been quoted have been orally, and many of them have been changed to fit the occasion. While the people who have been in favor of the movement have statistics and estimates, that have not been successfully disputed. These figures certainly have stood the test of several meetings, without being found in error.

Remember to vote against the eight hour law. On the ballot mark an "X" after number 321. We are all chiefly interested when questions come close to home, and this one

does. The passage of this law would mean that outside capital would steer clear of investing in lumber mills in a state where it would be impossible to pay wages for overtime, even if the men desired to work. And, if we understand the sentiment correctly, Bend rather wants a lumber mill.

If in doubt on any of the initiative measures, vote "NO."
