'The plan that has been discussed is to offer one mail delivery daily. the one delivery will cover the morning mail and the mail of the evening previous. Just the number that may be needed to give efficient service has not been thoroughly gone into, but it is estimated that at least three carriers will be used, owing to the scattered population that is served here.

Will Relieve Congestion.


