

NEW FORD TRUCK IS DRIVEN INTO CITY

The first Ford Model T one-ton truck to make its appearance here has just come from Portland. This is the first car of this type to be driven in Central Oregon and was driven from Portland by Mr. Grandy and Mr. Nadeau, who are connected with the Ford assembling plant in Portland.

This new model is not an attachment, but is a complete new product. Noticeable features of the truck on display at the Ford sales offices here now, include the worm drive and the wheel base. A temporary body has been placed on the truck and demonstrations will be given. Although this car has only recently been placed on the market, it has been in process of construction in the Ford factories for a number of months, and only about one for each agency has been placed out to this time.

moved into their new quarters in the court house building, all the offices are in good shape and all records filed, etc., for public inspection are kept in an orderly and convenient manner.
"We have also investigated the testimony submitted at the hearing of the Pilot Butte Inn investigation conducted before Judge Kates by the district attorney concerning alleged violations of the prohibition law, and find that although the evidence discloses that there were some intoxicating liquors in parts of the hotel, yet nothing discloses that there were any liquors there for the purpose of selling or giving away, or was sold or given away, and that there was not sufficient grounds for prosecution under the prohibition law. We consider that the results of the investigation conducted as aforesaid, obtained good results and was of

general benefit.
"We would recommend that as soon as can be done, and by the time of the next session of the Circuit court, that a suitable room be provided for the grand jury room, as the one now used is not so situated or located that the deliberations can positively be kept secret, and that the ventilation in same is extremely bad."

MADRAS WISS CONTEST FOR COUNTY SEAT

(Continued from Page 1.)
were agreed upon for the positions on the county board to be appointed by the governor, they in turn having the selection of the temporary county seat. The men agreed upon were expected to select Madras. When, however, Governor West came to appoint the court he ignored the convention choices and named one man each from the Culver, Metolius and the Madras sections.

When the court had organized, balloting for temporary county seat began, for nearly two hundred ballots the vote standing one each for Culver, Madras and Metolius. Finally, however, the Metolius vote was switched to Culver and Culver became the temporary county seat of Jefferson county.

Initiative Invoked.
Although the division law provided that the temporary county seat so selected should remain only until the next general election it made no provision for a vote for the permanent county seat, leaving that to be selected "in the manner provided by law," and when the Madras people, who were still after the county seat, came to look up the law they found that they had to obtain a big per cent of the votes over a majority. Faced by the knowledge that they could not get the necessary percentage they consulted W. S. U'Ren, the Portland attorney, who suggested that they try the initiative, and this they did. Under the initiative only a majority was necessary for the desired action, and

at the November election, 1916, the majority was given the Madras measure. A like measure to make Metolius the county seat was defeated. Culver's part in the campaign was to urge that both measures be voted down.

County Seat Moved.

Following the election, Culver, claiming that the Madras action was illegal and an abuse of the initiative, obtained an order restraining the certification of the result of the vote, the case being brought in Judge Duffy's court. On the 30th of December, 1916, Judge Duffy issued an opinion dismissing the order and on New Year's Day an angry mob, according to the Culver version, and a peaceable band, according to the Madras view, descended on Culver and effected not the temporary court house, removing all books, papers and furniture to Madras.

The county officers have since been conducted at Madras, pending the result of the appeal taken by Culver from Judge Duffy's decision. The Supreme Court now decides that they are to stay there.

Aside from local interest in the fight between Madras and Culver, today's opinion from the Supreme Court, sustaining Judge Duffy,
